**ORDER**

**Subject: First Appeal filed by Shri Shankaracharya Institute of Medical Sciences, Bhilai, Chhattisgarh, challenging the Letter of Permission (LoP) dated 10.09.2025.**

The Appellant Medical College has filed the present First Appeal dated 16.09.2025 under Section 28(5) of the National Medical Commission Act, 2019, challenging the Letter of Permission (LoP) dated 10.09.2025 issued by the Medical Assessment and Rating Board (MARB). The College had applied for an increase in intake of 100 MBBS seats (from 150 to 250 seats) for the academic year 2025-26. However, MARB, considering the available infrastructure, Faculty and Clinical material, issued the impugned LoP, increasing only 50 MBBS seats (From 150 to 200 seats) for AY 2025-26.

2. The Appellant Medical College submitted an application No. NMC/UGI/2025-26/000043 for an increase in intake of 100 MBBS seats (from 150 to 250 seats) for the academic year 2025-26. The Medical Assessment and Rating Board (MARB) reviewed the application based on the Establishment of Medical Institutions, Assessment and Rating Regulations, 2023; UG-MSR, 2023; and other relevant guidelines. During the scrutiny, MARB found various deficiencies.

3. Accordingly, the MARB issued a Show Cause Notice dated 29.06.2025 to the Medical College, highlighting the identified deficiencies and requesting additional information and a compliance report within specified deadlines. After reviewing the College's response, application, and document submitted, the MARB issued the impugned LoP to the Medical College, increasing intake of only 50 MBBS seats (from 150 to 200 seats) for AY 2025-26, considering the available infrastructure, Faculty and Clinical material. Being aggrieved, the Medical College has filed the instant 1<sup>st</sup> Appeal dated 16.09.2025 under Section 28 (5) of the NMC Act, 2019.

4. In this regard, the instant 1<sup>st</sup> Appeal has been admitted, and the Appeal Committee, constituted under the Chairmanship of Dr. Abhijat Chandrakant Sheth, Chairman, NMC and two Members, met on 01.10.2025 to consider the said Appeal filed by the Medical College. The following Appeal Committee members were present during the meeting:

c. Prof. (Dr.) Gangadhar Taduri, Department of Nephrology, Nizam Institute of Medical Sciences (NIMS), Hyderabad, Telangana- **Member**

5. The Appeal Committee has given a virtual hearing to the Medical College on 01.10.2025, represented by the Dean/Principal/Vice-Principal/HoD. The Medical College duly presented its submissions during the hearing.

6. The Committee reviewed the Physical Assessment Report dated 20.05.2025, wherein some deficiencies pertaining to the teaching faculty have been observed, which is a matter of record. The Committee also examined the AEBAS data for the period from 01.04.2025 to 31.08.2025, which indicated some cumulative faculty attendance deficiency, as per the UG-MSR-2023. However, it has been noted that the Medical College has adequate number of registered faculty to support the proposed increase in intake of 50 MBBS seats, from 200 to 250 seats.

7. Upon thorough review of all relevant records, including the Physical Assessment Report, AEBAS data, the submissions made by the college, the committee concludes that the available faculty, infrastructure and clinical material are adequate to support an intake of 250 MBBS seats. Accordingly, the Committee has decided to grant an additional 50 MBBS seats to the Appellant Medical College, thereby permitting a total intake of 250 MBBS seats for the academic year 2025-26.

8. In view of the above observations, the present 1<sup>st</sup> appeal is hereby allowed for an additional increase in intake of 50 MBBS seats (from 200 to 250 seats) for A.Y. 2025-26. The MARB is directed to issue the Letter of Permission (LoP) accordingly.

9. Accordingly, the 1<sup>st</sup> appeal filed by the Medical College stands disposed of.
