Instructions

- 1. The candidates **who are willing to retain their seat,** which was allotted in the 1st phase online counselling **need not participate** in this online counselling.
- 2. The candidates who are willing for re-allotment of colleges have to register and fresh Choice filling and locking should be done. Their allotted seat (allotted in 1st round of online counselling) will be open for choice filling in 2nd round of counselling.
- 3. If a candidate who has opted for upgradation from Round -1 allotted seat in this Round will necessarily have to vacate and cannot claim for retaining the seats.
- 4. The candidates who have already registered for first phase of online counselling and paid Rs. 250/- as Registration fee need not pay again.
- 5. Candidates should take care of choice filling.

- 6. Vacancy position for the Courses will be available on websites.
- 7. Selection committee does not take responsibility of Connectivity error.
- 8. Admission to POST BASIC B.SC NURSING courses shall be made by the ONLINE COUNSELLING on the basis of rank by applying the rule of reservation. The detailed online counseling procedures are available in Annexure.
- 9. Option once given during the online counseling cannot be changed later. Request for change of Branch / College, from one to another is not permitted after an option has been exercised at the time of admission.
- 10. Candidates selected for admission should give a self-declaration form at the time of the reporting to the concerned College that he / she is liable for forfeiture of selection / admission if suppression of facts mis-interpretation is found at any time during or after the admission to the course.
- 11. Candidates should download their provisional allotment order and join the course in the concerned Colleges on or before the date and time stipulated as mentioned in the allotment order.
- 12. REPORTING: The candidates should produce their original certificates in person at the time of joining in their selected Colleges.
- 13. For allotment in Self Financing Institution, the head of the concerned institution should ensure that only the fees approved by the fee Committee with respect to the allotted institution concerned is collected.
- 14. Request for re-allotment / Transfer of college will not be considered.
