IMPORTANT INSTRUCTIONS

The counselling for admission to Under Graduate M.B.B.S. / B.D.S. / B.A.M.S. / B.V.Sc.&A.H. (National – SS & NRI) degree courses for the year 2023-24 will be done by **CENTAC**.

The candidate seeking admission must apply online through **CENTAC** website (www.centacpuducherry.in) as per the schedule notified. Registration after the due date will not be entertained.

The candidate shall comply with all the instructions while filling in the application form.

Admission is based on valid **UG NEET - 2023** score and the candidate must have passed H.Sc. or its equivalent examination from any recognized board. Admission is based on the reservation criteria of Government of Puducherry

Please note that the candidature is subject to fulfilling the minimum eligibility requirements prescribed for applying to the concerned programme of study. In case a candidate does not meet the minimum eligibility criteria prescribed for applying to the concerned programme, it will be deemed to be done at the candidate's own risk and cost and if at any stage, it is found that the minimum eligibility requirements are not fulfilled, the admission if granted, shall be cancelled ipso facto and the fees paid, if any, shall not be refunded in any case.

CENTAC will carry out only the allotment of the seats. The admission is subject to the approval of The National Medical Commission / The Dental Council of India (DCI) and the Pondicherry University as per the norms.

The various terms and conditions mentioned in the Bulletin of Information are subject to the change made in the rules and regulations by the Government of Puducherry, affiliating University from time to time as per the decision of the Academic Council/ Executive Council and also binding regulations/ directions of the Ministry of Health & Family Welfare (Government of India) and/or National Medical Commission / DCI. CENTAC reserves the right to revise, amend, update, or delete any part of this brochure, as and when considered necessary.

The candidates are requested to visit the website **www.mcc.nic.in**/ **www.centacpuducherry.in** regularly for updated information.

For all the legal matters regarding CENTAC admissions, the jurisdiction will be the High Court of Chennai only.

1. INTRODUCTION

The counselling for allotment of candidates to M.B.B.S. / B.D.S. / B.A.M.S. / B.V.Sc.&A.H. (National Self-Supporting and NRI) courses for the year 2023-24 will be done by State Counselling Authority, CENTAC.

As per regulations framed under the Indian Medical Council Act,1956 and the Dentists Act-1948, admissions to 100% seats in M.B.B.S. / B.D.S. / B.A.M.S. / B.V.Sc.&A.H. (National Self-Supporting and NRI) will be done based on NATIONAL ELIGIBILITY CUM ENTRANCE TEST - NEET in all Medical / Dental Colleges run with the approval of the Medical Council of India / Dental Council of India/AYUSH/Veterinary Council of India.

The seats allotted under different categories are as below:

- Government quota seats in Government Colleges.
- Self-Supporting seats in Government Colleges.
- Government Quota seats in Private Colleges.
- Management Quota seats in Private Colleges.
- Minority (Management) Quota Seats in Private (Minority) Colleges.
- NRI Quota Seats in Government / Private Colleges.
- Foreign National Quota Seats in Government Colleges.

Medical Counselling Committee (MCC) in the Directorate General of Health Services, MoHFS, GoI does the Counselling for admission to the M.B.B.S. / B.D.S. seats under the following quotas:

- All India Quota Seats (Filled by DGHS):15% seats surrendered by Government Medical / Dental Colleges run as per the approval of MCI / DCI are filled through the counselling conducted by DGHS and are known as All India Quota seats.
- Central Institutions/Universities (Filled by DGHS)
- Seats in Deemed Universities (Filled by DGHS)

The Selection through Counselling for M.B.B.S., B.D.S. and B.A.M.S. courses is based on the **UG-NEET 2023** Score. Allotment to the B.V.Sc.&A.H. course under NRI Quota & Self Supporting - National Quota is also done through the **UG-NEET 2023** score.

Admission to the "Government Quota Seats" in Private and the Minority Colleges will be as per the laws / regulations / orders of Government of India, or of the Government of Puducherry, on the subject. The details regarding the Colleges and the number of seats will be published in the website.

Candidates need to apply **Online** only.

4. ALLOTMENT PROCEDURE

Candidates seeking allotment to UG Medical / Dental / Ayurveda Degree Courses in Government Colleges, Government Quota seats in Private Colleges, National Self-supporting seats in veterinary college, Management Quota seats and Minority Quota seats (Telugu & Christian) in Private Colleges and NRI seats in UG Medical, Dental and Veterinary colleges should apply Online through the CENTAC website.

- 1. Application must be submitted online only through the website www.centacpuducherry.in
- 2. Before filling the application, the candidate should read the Information Brochure available in CENTAC website carefully.

- 3. The Information Brochure 2023-24 can be downloaded for ready reference from CENTAC website
- 4. The application will be opened from 12-07-2023.
- 5. The last date for applying online is 18-07-2023.
- 6. The candidates should ensure the following:
 - 6.1. Upload recently renewed, scanned, self-attested photo copies of certificates. Original certificates must be produced only at the time of admission in the respective colleges.
 - 6.2. All certificates produced in support of various claims such as Residence, Regional Claim, Community, EWS, Freedom Fighter (FF), Ex-serviceman (ESM), Persons with Disability (PwD) & Meritorious Sports Persons (MSP), Christian / Linguistic Minority, NRI, etc., should be valid and obtained from the respective competent authorities.
 - 6.3. Residence and Community certificates issued by the Revenue Department, Govt. of Puducherry alone will be considered for claiming reservation benefits under Government / Christian / Linguistic Minority quota.
 - 6.4. Sports certificates must be countersigned by the concerned authorities.
- 7. Candidate should register and login to fill in all their details. Only on payment of application fee, the candidate will be allowed to enter his/her preferences of courses. Without filling the course preferences, the application will not be considered for allotment of seats. Candidate should bear in mind that the allotment of seats will be made based on the order of courses he/she has given as preference, subject to the availability, as per merit and reservation.
- 8. The candidate is advised to give as many choices of courses for which he/she is eligible in as many colleges as they wish. If a choice of course or college is not made, it will be deemed that he/she is not interested in the particular course or college.
- 9. The candidate should give their prioritization of course preferences in each round and the last date for submission will be published in CENTAC website. The candidate will not be able to edit his course preference after the last date. However, CENTAC reserves the right to

permit all the candidates to alter their preferences, if required. The decision taken will be duly intimated from time to time.

- 10. Number of seats in the colleges may vary depending on the approval of the concerned competent authorities of the Government of Puducherry. The seat matrix and fees structure will be published in CENTAC website after receiving the same from the concerned department of the Government of Puducherry.
- 11. Claim exercised with regard to Residence/ Community/ Special category are subject to verification of the submitted documents and cannot be changed once the **FINAL merit list is published**. However, CENTAC reserves the right to update the merit list in case of genuine claims supported by documentary evidences.
- 12. On verification of the candidates' credentials, the Draft Merit List will be published. Adequate time will be given to raise objections and submit documents, if any, and subsequently, the Final Merit List will be published.

Separate Merit Lists will be published for Government Quota Seats, Management Quota, Christian and Linguistic Minority Quota Seats. The candidate should refer to the CENTAC website www.centacpuducherry.in for the merit list.

13. Only **computer-based online allotment** will be done in Round I and in Round II except for NRI seats. Physical counseling or online counseling might be done in the event of a mop up round.

For NRI seats blended mode of Counseling will be done and the candidate may participate either directly report at the counselling centre (offline or physical mode) or participate through online mode (link will be sent to the candidate's e-mail ID before counseling). Detail guidelines will be published in CENTAC website before counseling.

- 14. Once the Provisional allotment list is published, the candidate must download the **Provisional Allotment Order** and report to the allotted college within the given time. If the candidate does not report within the given time, provisional allotment will be automatically cancelled. Similar procedure will be followed for the subsequent rounds of allotment as well.
- 15. Sliding will be allowed in Round 1 and Round 2. The candidates who have joined up to round 2 of NRI / AIQ / State quota shall not be eligible to participate in the further rounds of AIQ or state quota for the

academic year 2023-24. Refer NMC NEET UG 2023 Information Bulletin.

- 16. **Enabling Provision:** If all the students of a specified category have been admitted, and even thereafter, if any seat remain vacant for that specified category, the same will be de-reserved as per the guidelines.
- 17. The candidate will be informed of all the proceedings of CENTAC through SMS / E-mail. The same will also be published in the CENTAC website and in the public media by way of press releases. After the online application is opened the students should refer to the CENTAC website www.centacpuducherry.in regularly, for updates.
- 18. The final authority to settle disputes, if any, in any matter will be the Chairman, CENTAC.

5. STEPS FOR FILLING UP THE APPLICATION

- 1. All the candidates seeking admission to the Under-graduate Medical / Dental / Ayurveda / Veterinary (National SS and NRI) courses are required to apply online through the website www.centacpuducherry.in.
- 2. As a first time user, candidate shall create the login details as per the following steps:-
- On the "New Registration" page, candidate has to enter a valid Mobile Number and Email ID which would be used for all future communication for admission purpose. The candidate should take utmost care in providing the Mobile Number and Email ID, as all communications from CENTAC will be sent to the same.
- Candidate shall then create a new password (of maximum six characters) for online registration purpose. This password need not be the same as candidate's email account password, which is used to access one's email account.
- Candidate shall provide a valid mobile phone number (10 digit number without any prefix).
- The candidate should ensure that all the details given in the form are correct. This information will be used during the entire admission process. No change/modification will be allowed. Please be careful in filling up the required information in all aspect.
- 3. After successful registration the applicant shall login by using their "registered email-id" and "password" to fill the online application form.
- 4. Fill all the details in the application form.

- 5. Applicant shall upload the following documents (wherever necessary):
 - i. Passport size photograph of the applicant (20 to 50 KB)
 - ii. Scanned signature of the applicant (20 to 50 KB)
 - iii. Self attested copy of High School/Higher Secondary Certificate/Birth Certificate for verification of date of birth (100 to 500 KB).
 - iv. Self attested copy of Residence / Community / EWS / Freedom Fighter / Ex-Serviceman/ Person with Disabilities/Sports certificates, if applicable (100 to 500 KB).
 - v. Affidavit as per Annexure I-A should be uploaded in 20 Rs. E-Stamp paper duly attested by the Notary for claiming Puducherry Residence.
 - vi. Self attested copy of Admit Card of UG-NEET 2023 (100 to 500 KB).
 - vii. Self attested copy of Score card of UG-NEET 2023 (100 to 500 KB).

Note: The candidates are required to bring Printout of Application Form, Allotment letter and Original Certificates along with self attested photocopies of all the required documents at the time of Admission.

- 6. Once all the above-mentioned files are uploaded, applicant can proceed with "Make Payment". Applicant can also update the uploaded files and application form using "Back button" before making payment. Once payment is made, no changes can be made in the application.
- 7. The application submission process shall be completed only after making payment of the online application fee by the candidate.

9. Please note that the candidature is subject to the candidate fulfilling the minimum eligibility requirements prescribed for applying to the concerned programme of study. In case a candidate does not meet the minimum eligibility criteria prescribed for applying to the concerned programme, it will be deemed to be done at the candidate's own risk and cost, and if at any stage, it is found that the minimum eligibility requirements are not fulfilled, the seat allotted shall be cancelled ipso facto and the fees paid, if any, shall not be refunded in any case. Once the payment is made for the Application form, corrections, additions, deletions etc. in any manner shall NOT be allowed. The candidates are, therefore, advised to fill their forms carefully.

10. The candidate shall comply with all the instructions while filling in the application form.

6. ELIGIBILITY CRITERIA

A. ACADEMIC ELIGIBILITY

For admission to any course, the candidate should fulfill the necessary admission requirements for the respective degree courses, as prescribed by the Pondicherry University:

S1. No.	ELIGIBILITY CONDITIONS			
1	M.B.B.S. & B.D.S. Candidates seeking admission to the M.B.B.S./B.D.S, Degree courses must have passed H.Sc. (Academic)examination conducted by the Board of Higher Secondary Examination of Tamil Nadu or any other equivalent thereto, with a minimum of 50% marks (40% of marks for OBC/BCM/MBC/EBC/BT/SC/ST candidates) in aggregate, in the prescribed subjects of Physics, Chemistry and Biology or Bio-technology, Botany and Zoology. Further they should have studied English as one of the subjects and they must have passed the above four subjects individually.			
2	B.A.M.S. (a) Candidates seeking admission for B.A.M.S. course must have passed in the subjects of Physics, Chemistry, Biology & English individually and must have obtained a minimum marks taken together in Physics, Chemistry and Biology at the qualifying examination with a minimum of 50% marks for General and 45% of marks for OBC/BCM/MBC/EBC/OPH (General &OBC) and 40% of marks for SC/ST/BT&OPH. (b) The Higher Secondary Examination or the Indian School Certificate Examination which is equivalent to 10+2 Higher Secondary Examination after a period of 12 years study, the last two years of study comprising of Physics, Chemistry, Biology and Mathematics or any other elective subjects with English at a level not less than core course of English as prescribed by the National Council of Educational Research and Training after the introduction of 10+2+3 years educational structure as recommended by the National Committee on Education.			

Bachelor of Veterinary Science & Animal Husbandry [B.V.Sc. & A.H.]

Candidates seeking admission to the B.V.Sc.&A.H. Degree courses must have passed H.Sc. (Academic)examination conducted by the Board of Higher Secondary Examination of Tamil Nadu or any other equivalent thereto, with a minimum of 50% marks (40% of marks for OBC/BCM/MBC/EBC/BT/SC/ST Candidates) in aggregate in Biology / Botany & Zoology, Physics and Chemistry.

B. ELIGIBILITY TO APPEAR IN NEET (UG) - 2023

- a. Eligibility for appearing in NEET (UG), as per related Regulations of NMC and DCI are as follows:-
- i. He/she has completed 17 years of age at the time of admission or will complete that age on or before 31 December of the year of his/her admission to the first year of the Undergraduate Medical Course.
- ii. Accordingly, the lower age limit shall be as under:

For Candidates of General

iii. **Upper age limit:** As per Letter No. U-11022/2/2022-UGMEB, dated 09 March 2022 received from National Medical Commission (NMC), Under Graduate Medical Education Board (UGMEB) regarding the upper age limit, there is no upper age limit.

b. Criteria for NRI / OCI / Foreign Nationals

Non-Resident Indians (NRIs), Overseas Citizens of India (OCI), and Foreign Nationals are eligible for admission in Medical /Dental Colleges subject to rules and regulations framed by the respective State Governments, Institutions, and the Government of India, as the case may be. The NRI and OCI Applicants/Candidates have to upload a Certificate from the concerned Indian Diplomatic Mission in the country of their residence in support of their claim as an NRI/OCI Candidate, along with their online Application Form for

NEET (UG) - 2023 and retain the original of such document for producing it at the time of Counselling / Admission to the Courses covered under NEET (UG). Similarly, a foreign applicant for NEET (UG) 2023 shall also upload Documentary Proof (e.g. relevant pages of a valid passport or a Certificate from the Competent Authority in the country of his/her nationality regarding his/her citizenship status) in support of his/her Nationality, along with online Application Form. The format of Embassy Certificate and Citizenship Certificate or any Documentary proof of Citizenship are given in Annexure. Foreign nationals may confirm their eligibility from the concerned Medical/Dental/ College/State.

c. Eligibility of OCI cardholders for NEET (UG):

The Ministry of Home Affairs vide Notification dated 4 March 2021 specified the rights to which an OCI cardholder shall be entitled under the Citizenship Act, 1955.

Clause (4) (ii) of the said Notification reads as under:

"(4) parity with Non-Resident Indians in the matter of,-

(ii) appearing for the all India entrance tests such as National Eligibility cum Entrance Test, Joint Entrance Examination (Mains), Joint Entrance Examination (Advanced), or such other tests to make them eligible for admission only against any Non-Resident Indian seat or any supernumerary seat:

Provided that the OCI cardholder shall not be eligible for admission against any seat reserved exclusively for Indian citizens."

The above Notification provides the following Explanation:

"The OCI Cardholder (including a PIO card holder) is a foreign national holding passport of a foreign country and is not a citizen of India."

Similarly, the PIO cardholder and foreign nationals shall not be eligible for admission against any seat reserved exclusively for Indian citizens.

Hence, OCI/PIO will be treated as foreigners and be eligible for NRI seats only and will not be eligible for Indian National Seats including paid seats of deemed universities. This is also in pursuance of the Judgement dated 03 February 2023 of the Hon'ble Supreme court of India in W.P (C) No. 891 of 2021.

d. Eligibility for candidates studied in Open School

Candidates who have passed Class 12 from Open School or as private candidates shall not be eligible to appear for the 'National Eligibility Cum Entrance Test'. Furthermore, a study of Biology/Biotechnology as an Additional Subject at Class 12 level also shall not be permissible.*

* The candidates who have passed Class 12 level with Biology as an additional subject will also be eligible for MBBS Entrance Examination (as per Hon'ble High Court Order No. 2341/-W/DHC/WRIT/D-1/2019 dated 24/09/2019 in the Writ Petition (C) No. 6773/2019.

If the institute has to consider an examination of an Indian University or of a foreign/university to be equivalent to the Class 12 under intermediate science examination, the candidates shall have to produce a certificate from the concerned Indian University/Association of Indian Universities to the effect that the examination passed by him/her is considered to be equivalent to the class 12 under intermediate science examination.

*(NOTE: The proviso in italics has been a subject matter of challenge before the Hon'ble High Court of Delhi, Hon'ble High Court of Allahabad, Lucknow Bench, and Hon'ble High Court of Madhya Pradesh at Jabalpur. The provisions of the regulations disqualifying recognized Open School Board candidates and the candidates who have studied Biology/Biotechnology as an Additional Subject has been struck down. The Medical Council of India has preferred Special Leave Petitions before the Hon'ble Supreme Court and Appeals in the Hon'ble High Courts. Therefore, the candidature of candidates in the NEET (UG) - 2023 who have passed the qualifying examinations i.e. Class 12 from National Institute of Open Schooling or State Open Schools or State candidates recognized Boards; from Biology/Biotechnology as an additional subject shall be allowed but subject to the outcome of Special Leave Petitions/Appeals filed by the Medical Council of India.

For Minority Quota Seats in Private Medical / Dental Colleges

- (i) For Minority Quota seats in Minority Medical / Dental Colleges candidates who are residents of the U.T. of Puducherry and belonging to respective minorities are only eligible, i.e., for the minority quota seats in PIMS, candidates who are resident of U.T. of Puducherry and belonging to Christian religious minority alone are eligible. For the minority quota seats in SVMC&RI, candidates who are resident of the U.T. of Puducherry and belonging to Telugu linguistic minority alone are eligible. The details of these seats and the fee structure will be notified by the Health Department, Government of Puducherry. Candidates are advised to check the CENTAC website for updates on these.
- (ii) U.T. of Puducherry candidates claiming seats under **Christian Minority Quota** should produce valid proof like Transfer Certificate or Community Certificate to prove his/her religion is **CHRISTIANITY**. If CHRISTIANITY is not mentioned in TC or Community Certificate, attach certificate as per Annexure VII.
- (iii) U.T. of Puducherry candidates claiming seats under Telugu Minority Quota should produce valid proof like Transfer Certificate or Certificate/letter from the school last studied stating that his/her mother tongue is **TELUGU as per the school admission records**. If Mother Tongue TELUGU is not mentioned in TC, attach certificate as per Annexure VIII.

(iv) Conversion of Minority Quota seats into General Management Ouota seats:

In case these minority quota seats are not filled in the TWO rounds of Counselling, then these unfilled seats will be converted to general management quota seats and filled on All India basis during Round 2.

After exhausting the entire Minority merit list of candidates, the unfilled Minority seats will be converted into All India Management seats and operated in Round 2.

The course preferences for UG NEET M.B.B.S. Management quota seats in Minority institutions will be enabled in Round 2 and will be operated after converting unfilled seats in Minority quota seats in Round 2 itself.

Note: In Round 1, M.B.B.S. Management quota seats for Minority Institutions will not be enabled for PIMS, Puducherry (Christian Minority), Puducherry & SVMCH&RC, Puducherry (TELUGU Minority).

(v) For NRI /NRI ward/OCI /PIO/Foreign Nationals Candidates

For claiming NRI/ NRI Ward / NRI Sponsored / OCI / PIO / Foreign Nationals, candidates should submit the following certificates, whatever applicable.

- i. Candidate's parents resident certificate issued by the Embassy of that country complying with the Income Tax Rules / any other certificates to establish evidence that they are resident of that country / affidavit on Rs.100/- estamp paper to that effect.
- ii. Candidate's passport / VISA / Resident VISA.
- iii. Citizenship of the candidate.
- iv. Income Tax Documents required as per the Income Tax Act 1961. (If applicable)
- v. If NRI Sponsored with NRI Sponsor's acceptance certificate. (If applicable)
- vi. Candidate's Study certificate for having studied outside India where applicable for the qualifying examination.

Note: For the purpose of verification e-document may be considered with regard to NRI ward certificate subject to submitting the original at the time of taking the admission.

For NRI seats blended mode of Counseling will be done and the candidate may participate either directly report at the counseling centre (offline or physical mode) or participate through online mode (link will be sent to the candidate's e-mail ID before counseling). Detail guidelines will be published in CENTAC website before counseling.

(vi) Conversion of seats in BAMS/BDS

BAMS/BDS - if any vacancy in Govt. quota/NRI after Stray Round of Counseling that may be filled with candidates on All India basis under Self-Supporting mode.

8. MODE OF RESERVATION (Applicable for Seats in Govt. Colleges and Govt. Quota Seats in Private Colleges in the U.T. of Puducherry)

- 8.1 The Mode of Reservation while allotting the seats will be as follows:
 - All the candidates should be Indian National and Residents of Puducherry.
 - Vertical Reservation First General, EWS, OBC, MBC, EBC, BCM, SC, ST, BT.
 - Regional Reservation (Compartmentalized Horizontal Reservation) Refer Volume I General Information Page 28, sl, no. 22.
 - Horizontal / Special Reservation FF / ESM / PwD / Sports will be

done if adequate seats are not filled after fixing vertical reservation, i.e., if the requisite seats are not filled while doing vertical reservation, the last candidate in the respective category will be replaced as per merit.

8.2. **De-reservation of seats**

The seats will be de-reserved as per the conversion criteria detail in Annexure-XII.

9. NATIONALITY CRITERIA

A candidate seeking admission through CENTAC should be an Indian National. However, French Nationals residing in the UT of Puducherry and covered by the terms of the Treaty of Cession shall be treated on par with Indian Nationals, for the purpose of admission to all the courses.

10. RESIDENCE CRITERIA

Reservation of seats shall be as per the norms of the Government of Puducherry. (G.O. Ms. No. 64 Dated 25/05/2006, Chief Secretariat (Edn. I)).

An applicant is considered to be a Puducherry resident if he/she is an **Indian National** and satisfies at least one of the following criteria:

- i) The candidate or whose parent (either Mother or Father or Both) or Guardian (in case of children who have lost both the parents) has been residing continuously in this Union Territory for at least five years preceding the date of application. (Refer Annexure I-1).
- ii) Those who have passed the SSLC / HSC or any other public examination and for that purpose had undergone academic studies continuously for 5 successive classes immediately preceding the qualifying examination (including the year of qualifying examination) in a recognized educational institution located in Pondicherry UT and having their residence in Pondicherry UT for 5 years continuously during that period. Mere stay in places such as residential hostel would not amount to residence. (Attach certificated as per Annexure I-2a & 2b).
- iii) Children of natives of U.T. of Puducherry who have declared any place in U.T. of Puducherry as their home town and so certified by their respective Heads of Office. Nativity Certificate in the prescribed format has to be enclosed. (G.O. Ms. No. 64 dated 25th May 2006).
- iv) a) Children whose parents are Central/ State Government Servants/ Defense Personnel/ Central Paramilitary Forces/ Employees of Public Sector Undertakings wholly or substantially owned either by the Central

Government or by the Puducherry Administration posted and serving in U.T. of Puducherry for at least a minimum continuous period of **three** years immediately prior to the last date of submission of application. (Attach certificate as per Annexure I-3a & 3b).

- b) Children of the above said employees should have studied H.Sc. two years in any of the schools in the U.T. of Puducherry and should have passed the qualifying examinations (H.Sc.) from the same school. (G.O. Ms. No. 04, Puducherry dated 09.02.2016 of the Chief Secretariat (Hr. & Tech. Edn.), Puducherry.
- c) Candidates seeking admission to the seats earmarked for the Residence of U.T. of Puducherry shall not claim the benefit of Residence in any other state / U.T. An affidavit / undertaking as provided in the **Annexure I-A** shall be submitted by the parents / Guardian of the candidate while submitting their application. If it is found later that the candidate has claimed Residence / Nativity in any other state / U.T. then the admission will be liable to be cancelled at any stage. Further, during the course of study, even if it is subsequently found that any candidate had produced a False Nativity / Residence Certificate or given a false undertaking, it will result in Expulsion of the candidate from the course and also initiation of criminal proceedings against the candidate as well as his / her parents as per provision of the Law.
- v) Children of Defence Personnel who were killed or disabled in action and children of Central Government Servants/ Pondicherry U.T. Government Servants/Defence Personnel/ Employees of Public Sector Undertaking wholly or substantially run either by the Central Government or by the Puducherry U.T. Administration who died while in the service in the Puducherry U.T (Attach certificate as per Annexure I-4/5).
- vi) French nationals residing in the Puducherry U.T. and covered by the terms of the "Treaty of Cession" shall be treated on par with the candidates who produce the prescribed Puducherry U.T. Residence Certificate. Such French Nationals will not be required to produce Residence Certificate; instead they should produce a "Certificate of Registration" issued for this purpose by the French Consulate at Puducherry. Children of these French Nationals shall not be considered for admission under the quota of non-resident. (Submit Proof of Residence from French Consulate, Puducherry)

All the above certificates will be scrutinized first by a committee appointed by the Secretary (Revenue), before final merit list is prepared. Tahsildars of various Taluks and Revenue Officers will be the Members of this Committee.

11. <u>RESERVATION OF SEATS</u> (Applicable for Seats in Govt. Colleges and Govt. Quota Seats in Private Colleges in the U.T. of Puducherry)

Reservation in admission to various courses for the candidates of the U.T. of Puducherry belonging to different categories is as given below. Further, OBC / BCM / MBC / EBC / BT /SC /ST candidates are also eligible for selection under Open General category in addition to the reservations made to them.

1. Scheduled Caste (SC)

Candidates claiming admission under this category should belong to a caste which is recognized as Scheduled Caste under "the **Constitution (Pondicherry) Scheduled Castes Order 1964**" dated 05.03.1964, read with "The Constitution (Scheduled Caste) orders (Second Amendment) Act 2002 (Central Act 61 of 2002) and should enclose the required certificate issued by an Officer of the Department of Revenue & Disaster Management, Puducherry, not below the rank of Deputy Tahsildar.

2. Scheduled Tribe (ST)

Candidates claiming admission under this category should belong to a caste which is recognized as Scheduled Tribe under "the **THE CONSTITUTION (PUDUCHERRY) SCHEDULED TRIBES ORDER, 2016**" dated 22.12.2016 and

should enclose the required certificate issued by an Officer of the Department of Revenue & Disaster Management, Puducherry, not below the rank of Deputy Tahsildar.

3. Other Backward Classes (OBC), Most Backward Classes (MBC), Extreme Backward Classes (EBC), Backward Classes Muslims (BCM) and Backward Tribes (BT)

Candidates claiming admission under these categories should enclose the recently renewed certificate issued by an Officer of the Department of Revenue and Disaster Management, not below the rank of Deputy Tahsildar.

4. Freedom Fighter (FF)

Candidates claiming admission under this category should be Children / Grand Children of Freedom Fighters and they should enclose the necessary certificate issued by the Officer-in- charge, Freedom Fighters Cell, Government of Puducherry.

5. Wards of Ex-servicemen (ESM)

Those who are registered as Ex-servicemen in the Department of Sainik Welfare (DSW), Government of Puducherry and have got an Ex-servicemen / Widow of Ex-servicemen identity card from DSW should enclose the necessary certificate issued by the Director, DSW, Puducherry.

6. Person with Disabilities (PwD)

Candidates with at least 40% impairment irrespective of the type of disability i.e., locomotor, visual or SEVERE dyslexic shall be eligible for the benefits of the PwD category. Leprosy-cured candidates who are otherwise fit to pursue the courses are also included in this category.

For eligibility under the Persons with Disability Quota, locomotor disorder of lower limbs should be between 40% to 80%. For more details, candidates are requested to refer to the BOARD OF GOVERNORS IN SUPERSESSION OF MEDICAL COUNCIL OF INDIA AMENDMENT NOTIFICATION No. MCI-34(41)/2018-Med./170045, dt. 04-02-2019.

The candidates seeking admission to M.B.B.S. / B.D.S. / B.A.M.S. / B.V.Sc.&A.H. (National SS & NRI) courses under this category will be required to undergo a second Medical examination by a Medical Board constituted for the purpose by the Director of Health and Family Welfare Service, Puducherry, to ascertain and confirm the nature and extent of physical disability.

Candidates with any other DISABILITY other than the locomotor disability of the lower limb will not be considered for admission into M.B.B.S. / B.D.S. / B.A.M.S. / B.V.Sc.&A.H. (National SS & NRI) courses under this special category. Such application will be summarily rejected without any intimation to the candidates.

The certificates must be obtained within **three months** prior to submitting the application for seeking admission under the category. In case the certificate was obtained earlier, the application will be rejected. The medical certificate issued by the District Medical Board of the area concerned for this purpose is subject to the confirmation by the Director of Health and Family Welfare Service.

The decision of the Director of Health and Family Welfare Service, Puducherry, in this regard will be final.

The candidates seeking admission under this category should produce a full size photograph exhibiting the deformity.

7. Meritorious Sports Person (MSP)

- a. The highest achievement of the candidates in only one annual tournament under the listed sports disciplines in a year will be considered for awarding marks.
- b. The list of Sports Disciplines eligible for seats under sports quota are as follows:

- c. Participation / Achievements in sports / games shown in the list alone, immediately preceding **five** years to the year for which admission is sought will be taken into account. National / State Level Championships / Tournaments conducted by Organizations / Federations recognized by Indian Olympic Association / Ministry of Youth Affairs and Sports, New Delhi alone will be considered for award of marks (Recognition by the Indian Olympic Association / Ministry of Youth and Sports, New Delhi should be relevant to the years concerned).
- d. Open /Invitational Tournaments of any kind will not be considered.
- e. For Tennis, achievements of Top 3 players by his/her position in the ranking list published by ATTA based on the ranking rules and the final rankings of the previous 4 years will be awarded marks for achievements and participation (Necessary forms from Associations are to be enclosed).
- f. For Cricket the Annual Official Championship / Tournaments conducted within the country under the auspices of the BCCI at the District / State/ National Level alone will be taken into consideration for that year.
- g. The participation / achievements of candidates with nativity in the Puducherry Union Territory and who represented the Union Territory of Puducherry alone are eligible for marks under the National Category.
- h. Union Territory of Puducherry candidates are eligible to apply for admission under the Sports Quota and candidates of KVS/NVS/CBSE Schools within Puducherry are also eligible for marks.
- i. All the achievement certificates are to be supported necessarily by the relevant participation certificates and appropriate form /certificates.
- j. No further enclosures of certificates will be entertained after the last date for submission of completed application.
- k. A candidate can utilize the sports quota only once for these admissions.

- 1. The relevant attested copies of the certificates issued by the appropriate authorities as detailed in the G.O Ms.53, dt.24.05.2012 are to be submitted along with the application.
- m. A committee constituted to scrutinize the applications received under this category will rank the candidates based on the marks assigned to the certificate enclosed along with the application and the sports merit list will be published in the CENTAC website.

12. MERIT LIST

Merit List will be drawn based on UG-NEET - 2023 rank, in which Reservation Policy of U.T. of Puducherry will be applied.

13. SEAT MATRIX

Seat Matrix with details of reservation will be published in the CENTAC website after receiving the same from the Health Department, Puducherry. Please refer the CENTAC website continuously for updates.

14. COUNSELLING PROCEDURE

Admission to the UG M.B.B.S. / B.D.S. / B.A.M.S. / B.V.Sc.&A.H. (National SS & NRI) courses is based on the UG-NEET - 2023 Rank.

Round 1 and Round 2 allotment will be Online for Government Quota & Management Quota and for NRI in blended mode in which candidate may attend either online or offline. Mopup and Stray vacancy Counselling can be either Online or Offline. CENTAC reserves the right to do either Online or Offline counselling based on necessity.

Online allotment will be done based on the candidate's course preferences, category of seats, reservation and NEET Rank.

Both Round 1 and Round 2 allotment is based on the course preferences submitted by the candidates before the last date for updating the course preferences. If the course preferences are empty, then allotment will not be done.

For Round 2, candidates should submit their willingness and Registration Fees (only for M.B.B.S.) before submitting their course preferences.

After publishing the provisional allotment list, allotted candidates should download the Allotment Order from the dashboard using their Login credentials.

Allotted candidates will be instructed to report to the college with the copy of the Application form, Provisional Allotment Order and all other original certificates within the scheduled date and time.

After verification of the originals and payment of fees, colleges will confirm the provisional admission of the candidates and issue the Admission slip to the candidate.

Mopup and Stray Vacancy Counselling – Detailed Guidelines will be published in CENTAC website before the counselling as per instructions received from the competent authority of Government of Puducherry.

Sliding in Round 2

If any seat is allotted during sliding in round 2, seat allotted in previous round will be automatically forfeited.

Sliding from one college to another college is permitted during counseling only, based on merit and rule of reservation.

Individual request for transfer of college will not be permitted under any circumstances.

Mutual transfers will not be permitted under any circumstances.

In case of Offline Counselling, due to unforeseen reasons, if a candidate cannot attend the counseling on the specified date and time, he/she can authorize a representative to attend the counseling on his/her behalf. The authorized representative should produce an undertaking and authority letter for allotment along with the requisite original documents. The allotment made to the authorized representative shall be binding on the candidate.

Strict discipline should be maintained by the candidate for smooth conduct of counseling. If the students are found to indulge in any untoward activities, they will be debarred from the counseling and selection, for the present and subsequent academic sessions.

Special Note to Students who have been allotted seats in JIPMER

It is observed that some of the students who have got seats allotted in M.B.B.S. in JIPMER do not opt out and unnecessarily block the seat allotted in CENTAC thereby causing unwarranted sliding. CENTAC will obtain the list of candidates who have been allotted seats in JIPMER and these candidates will not be allotted any seats despite their eligibility. If any candidate who has been selected in JIPMER wants his/her name to be considered, then the candidate has to deposit Rs.1,00,000/- (Rs. One Lakh only) as Cautionary Deposit. This Cautionary Deposit will be forfeited if the candidate is allotted a seat by CENTAC and fails to join within the prescribed date.

15. REGISTRATION FEES

In addition to the Application fee, for M.B.B.S. / B.D.S. / B.A.M.S. / B.V.Sc.&A.H. (National SS & NRI) counselling, candidates need to pay the **Counselling and Registration fees** for participating in counselling.

Forfeiture of Registration Fee / Tuition Fee

- (i) After publication of Final allotment list in 2^{nd} round, if any candidate fails to join the college then the registration fee as mentioned above will be **forfeited**.
- (ii) During mop up counselling, seats will be allotted only after the entire tuition fee is paid, preferably by way of DD (Demand Draft) or through RTGS/NEFT. If the student fails to join the allotted college after mop up counselling, then the Registration fees (an amount of Rs. 1,00,000/- for GQ and Rs.200000/- for MQ/NRI) will be forfeited. In case, the college is not able to fill the seat from the 1:10 list sponsored by CENTAC, then the entire tuition fee will be forfeited.
- (iii) If the college is able to fill the seat, the remaining amount will be refunded after **6 months** so that this acts as a deterrent for blocking of seat. Therefore, it is advised that the candidate makes a thoughtful decision before taking the seat in mop up counselling. **CENTAC reserves** the right to modify these guidelines relating to mop up counselling, depending upon necessity.

Refund of Registration Fee / Tuition Fee.

(i) In case the candidate is not allotted any seat during the 2nd Round and Mop Up Round, the Registration Fees / Tuition Fees will be refunded to the same account of the candidate from which payment had been made.

(ii) The candidates should keep their bank account active until refund process is completed. The candidates are advised not to use unrelated bank accounts for remitting Registration Fee / Tuition fee amount. CENTAC will not entertain such requests.

16. FEE STRUCTURE / TUITION FEE

As prescribed by the "Fee Committee" for the year 2023-24.

Candidates are advised to go through the details of tuition fee notified by the Health Department which will be published in the CENTAC website. Candidates are also advised to go through the notification carefully and verify from the concerned Institution the components not covered in the tuition fee (e.g., Hostel fee, etc.).

For UG M.B.B.S. / B.D.S. courses, candidates should pay the TUITION FEES to CENTAC account using the payment link in their login dashboard OR use the Account details published in CENTAC website.

For OTHER courses, candidates may pay the TUITION FEES directly to the college.

17. SAVING CLAUSE

- a. CENTAC reserves the right to issue additional guidelines, or modify or delete the guidelines already issued, based on necessity.
- b. CENTAC shall be the final authority to settle disputes, if any, that may arise.

18. MODE OF COMMUNICATION

Any candidate applying for admission for the year 2023-24 is deemed to have read the content in this prospectus and agrees to all the conditions and clauses and will not have the right to challenge any of the regulations.

The candidates are requested to constantly refer the CENTAC Website www.centacpuducherry.in for latest updates and announcements.

SMS / Email will also be sent regarding updates and announcements. Press release will also be published.

19. LOWERING OF CUT-OFF




