In view of the above and in modification to this office notification dt:25-09-2025, the Competent Authority has decided to notify the following instructions in connection with exercising web option for above said two colleges i.e.(1) Anna Gowri Medical College and Hospital, Parameshwaramangalam, Puttur Mandal, Tirupati District, Andhra Pradesh and (2) Gayathri Vidhya Parishad Institute of Health Care & Medical Technology, Visakhapatnam under Phase-II of counselling for admission into MBBS Course under the Competent Authority Quota for the academic year 2025-26:-

1) <u>Candidates who joined MBBS course under Phase-I allotments of Competent Authority Quota:</u>

a) Anna Gowri Medical College and Hospital, Parameshwaramangalam is now inserted by default and displayed last option as follows:

- c) Those candidates who are not interested to opt the said two colleges, can ignore the same, but the said colleges will be kept as last options as explained under Point No.1. Further, such NOT INTERESTED candidates are not eligible for upgradation in Phase-II or further phase(s) of counselling under Competent Authority Quota, except for default sliding within the same college as per the procedure notified earlier.
