It is hereby informed that the Government of Telangana has issued G.O.Ms.Nos. 200 & 201, Health, Medical & Family Welfare (C1) Department, Dated: 03.11.2025, wherein 15% of MQ1 category seats are made open to the candidates from all over the country, and the remaining 85% of MQ1 category seats in Non-Minority & Minority Private Medical Colleges are reserved for local candidates of Telangana State.

Whereas, the Telangana State Un-aided, Non-Minority Professional Institutions (Regulation of Admissions into Post Graduate Medical and Dental Professional Courses), Rules, 2017 were issued vide G.O. first read above. Subsequently, these rules were amended vide G.Os second and third read above.

- 2. And whereas, the Telangana State Un-aided, Non-Minority Professional Institutions (Regulation of Admissions into Post Graduate Medical and Dental Professional Courses) Rules, 2017 stipulates that 25% of the sanctioned intake of seats, course-wise, under the Management Quota Sub-category-1, shall be filled by candidates in General Merit based on the NEET ranking.
- 3. And whereas, upon review of the existing admission framework, the Government has decided to introduce a rational division within the Management Quota Sub-category–1 seats, by allocating 85% to local candidates of Telangana and 15% as All India Quota seats to candidates from across the country, thereby harmonizing regional preference with national-level opportunity.
- 4. And whereas, according to sub-section (3) of section 3 of the Telangana Laws (Change of Acronyms) Act, 2024 (Act No.15 of 2024) for the words "Telangana State" wherever they occur, while referring to the Laws, the word "Telangana" shall be substituted therefor.
- 5. Now, therefore, the Government, after careful consideration of the matter, have decided to amend the Telangana Un-aided, Non-Minority Professional Institutions (Regulation of Admissions into Post Graduate Medical and Dental Professional Courses) Rules, 2017 suitably.
