Note: Incomplete applications in any form will not be processed and shall be summarily rejected and EMRB, NMC shall not be responsible in this regard. Thereafter, the portal for applying the application shall be closed.	

3. It is advised that the candidates may not wait for the last date to apply and should submit their applications as early as possible. It may also be noted that the issuance of an Eligibility Certificate involves multiple checks to ascertain eligibility in accordance with the provisions of the regulations in vogue. The candidates should fill the application form scrupulously in order to avoid unnecessary to & fro movement of the application to resolve the deficiencies.
