O R D E R

1. It is an admitted fact that pending litigation, all the petitioners have completed their courses.
2. In this view of the matter and in the peculiar facts of the present case, we direct that the admission, conduct and conclusion of the course by the petitioners are regularized. The concerned authorities shall issue degrees in favour of the petitioners within a period of three weeks from today.
3. We further direct the National Medical Commission to instruct the University for taking necessary action.
4. Insofar as the question of law is concerned, we will hear Mr. Gaurav Sharma, learned senior counsel appearing on behalf of the Medical Commission and pass orders for appropriate declaration of law.
