PUBLIC NOTICE

Subject: Submission of Annual Disclosure Report (ADR)-2025 for Postgraduate Medical Courses in accordance with the Maintenance of Standards of Medical Education Regulations, 2023.

The Maintenance of Standards of Medical Education Regulations, 2023 (MSMER-2023) stipulate that, "After its establishment, every medical college or medical institution shall furnish an Annual Disclosure Report to the concerned Board, in compliance with the conditions prescribed under the notified Minimum Standards Requirements (MSRs) by UGMEB or PGMEB, and the regulations of the National Medical Commission (NMC), as applicable."

2. Accordingly, all Postgraduate Medical Colleges/Institutions **conducting PG Medical Courses** are required to **submit** the Annual Disclosure Report (ADR)-2025 for the period from **01.01.2025 to 31.12.2025** in respect of **each PG Medical Course** being conducted by them.

The Annual Disclosure Report shall comprise the following two parts:

- 1. Standard Assessment Form – Part A**
(*Institutional information common to all PG specialties*)
- 2. Standard Assessment Form – Part B**
(*Specific to the concerned Broad Specialty/Super Specialty course*)

The requisite forms are available on the NMC website under the **Information Desk** → **Download Application Forms** Section.

- SAF-A (for institutional information) at Sr.No.2
- SAF-B (for specialty specific) (Broad – from Sr. No.3.1 to 3.38) (Super Specialty – from Sr. No.4.1 to 4.48)
- Master SAF-B Form at Sr. No.2.1 (to be used if specialty-specific SAF-B is not available)

3. The portal for submission of Annual Disclosure Report by Colleges can be accessed at the following URL:

4. It may also be noted that:

(a) Clinical material and investigative workload and faculty attendance: Information to be provided in various tables under column heading showing Last year/ year 3 **will be of year 2025** (01.01.2025 to 31.12.2025).

(b) Faculty attendance Information under column heading for the year part of the year **will also be of year 2025** (01.01.2025 to 31.12.2025) or part of it.

(c) In the table of total eligible faculties and Senior Residents, only eligible faculties fulfilling **attendance requirement for 2025** (01.01.2025 to 31.12.2025) will be mentioned.

5. All the Medical Colleges/ Institutes running PG Medical Courses are directed to fill in the relevant forms and submit the same, along with the requisite fee of **Rs. 50,000/- plus 18% GST (=Rs.59000/-) for each PG Medical Course**, on the designated NMC's portal for this purpose. The payment of fees by colleges shall be **strictly restricted** through designated window on NMC portal. **No other mode of payment will be accepted.**

6. The path for uploading of ADRs and payment of fees shall be as under:

Annual Disclosure Report (ADR) for PG Medical Course	
Step-1	<ul style="list-style-type: none"> Website ADR for PGMEB Course – Open through Login ID/PW. Carefully read and adhere to the instructions provided.
Step-2	<ul style="list-style-type: none"> Check the autofilled information. Upload SAF Form-A.
Step-3	<ul style="list-style-type: none"> Upload SAF-B for each of the PG Broad/Super Specialty individually. It may be NOTED that only PDF uploaded document, which is legible and readable will be accepted.
Step-4	<ul style="list-style-type: none"> On submission of SAF-A & B forms, option for payment of fees shall appear on portal. Payment of fees option will be opened for one transaction only. It may be noted that payment for all uploaded ADRs may be made in one-go; separate transaction for each specialty is not permissible.
Step-5	<ul style="list-style-type: none"> On successful submission of Form/fees, a final receipt will be provided in NMC Portal for the Broad/Super Specialty.

7. The time-line for submitting the required details along-with the applicable fee on the NMC portal is from **01st June, 2026 (10.00 AM) to 30th June, 2026 till**

midnight. NO EXTENSION WILL BE GRANTED BEYOND THIS DATE AND FORMS WILL NOT BE ACCEPTED PHYSICALLY.
