Notice for INI Candidates:

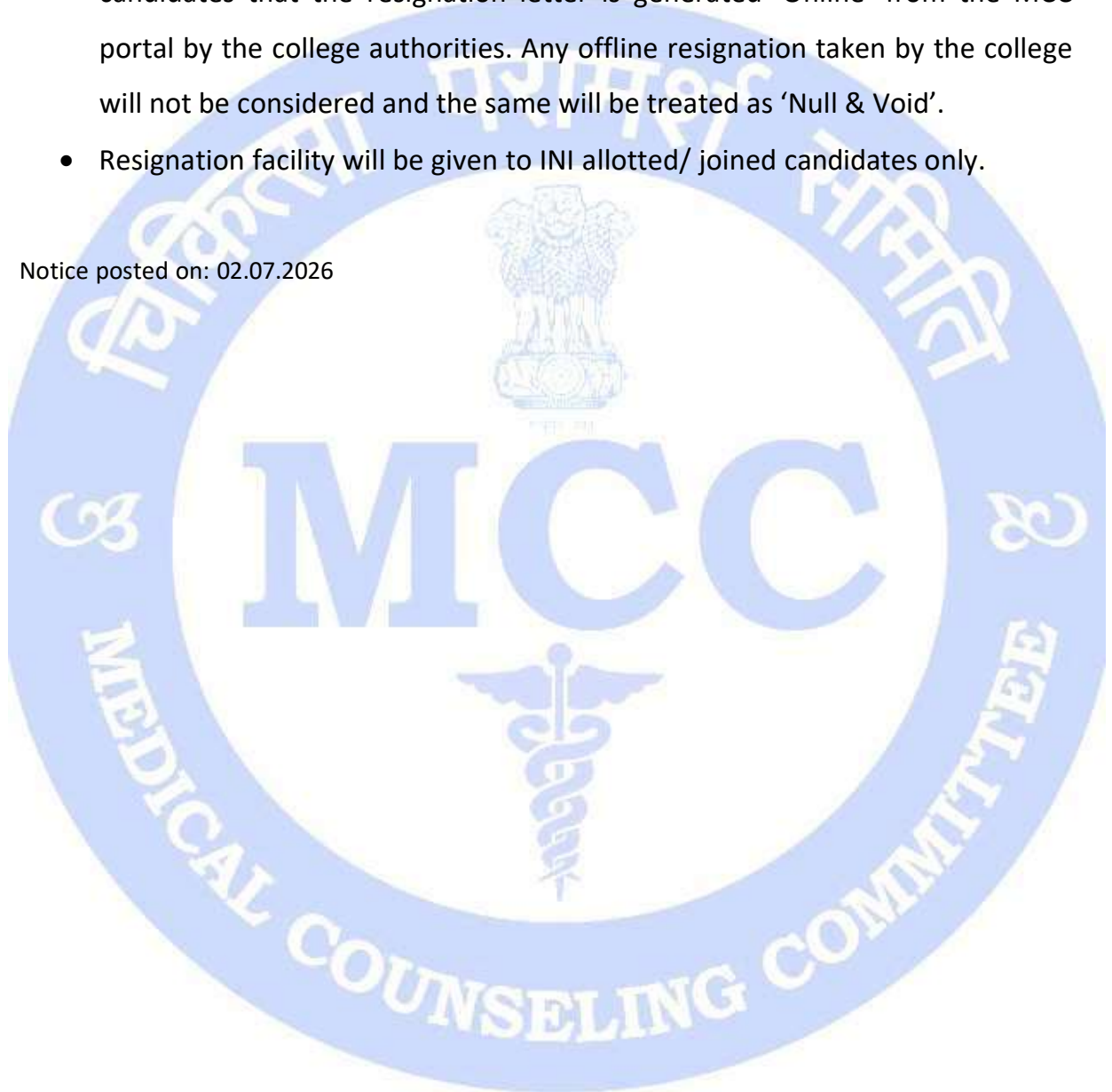
This is to inform that MCC is in receipt of many resignation requests from SS-2025 candidates who have been allotted INI seats. In this regard, **facility of resignation is being provided to INI allotted candidates** who have also joined seats allotted through MCC in Round-1 of All India SS-2025 Counselling.

In view of the above, INI candidates may note the following points:

- INI allotted candidates who want to **RESIGN** their Round-1 seat allotted through MCC counselling should send their **INI-SS RANK LETTER** along with following undertaking (Copy attached) to MCC on email id: colleges.superspeciality@gmail.com **from 02.07.2026, 02:00 PM onward to 04.07.2026 upto 01:00 P.M. Candidates who send e-mails along with required documents will be allowed to RESIGN from their JOINED SEAT, only. However, such candidates who want to resign from SS-2025 of MCC for participating in INI-SS, will not be eligible to participate in further rounds of SS-2025 Counselling to be conducted by MCC.**
- The resignation facility will be available from **02.07.2026, 05:00 PM onward to 04.07.2026, till 06:00 P.M, only. The final list of such candidates will be uploaded on MCC website in due course. The refund of security deposit will be processed for those candidates only who's resigned through online portal along with all formalities completed within given time frame.**

- The candidates who wish to resign their seat through SS-25, MCC counselling, may approach to their respective allotted college for resignation and collect their original documents within stipulated time. It should be ensured by the candidates that the resignation letter is generated 'Online' from the MCC portal by the college authorities. Any offline resignation taken by the college will not be considered and the same will be treated as 'Null & Void'.
- Resignation facility will be given to INI allotted/ joined candidates only.

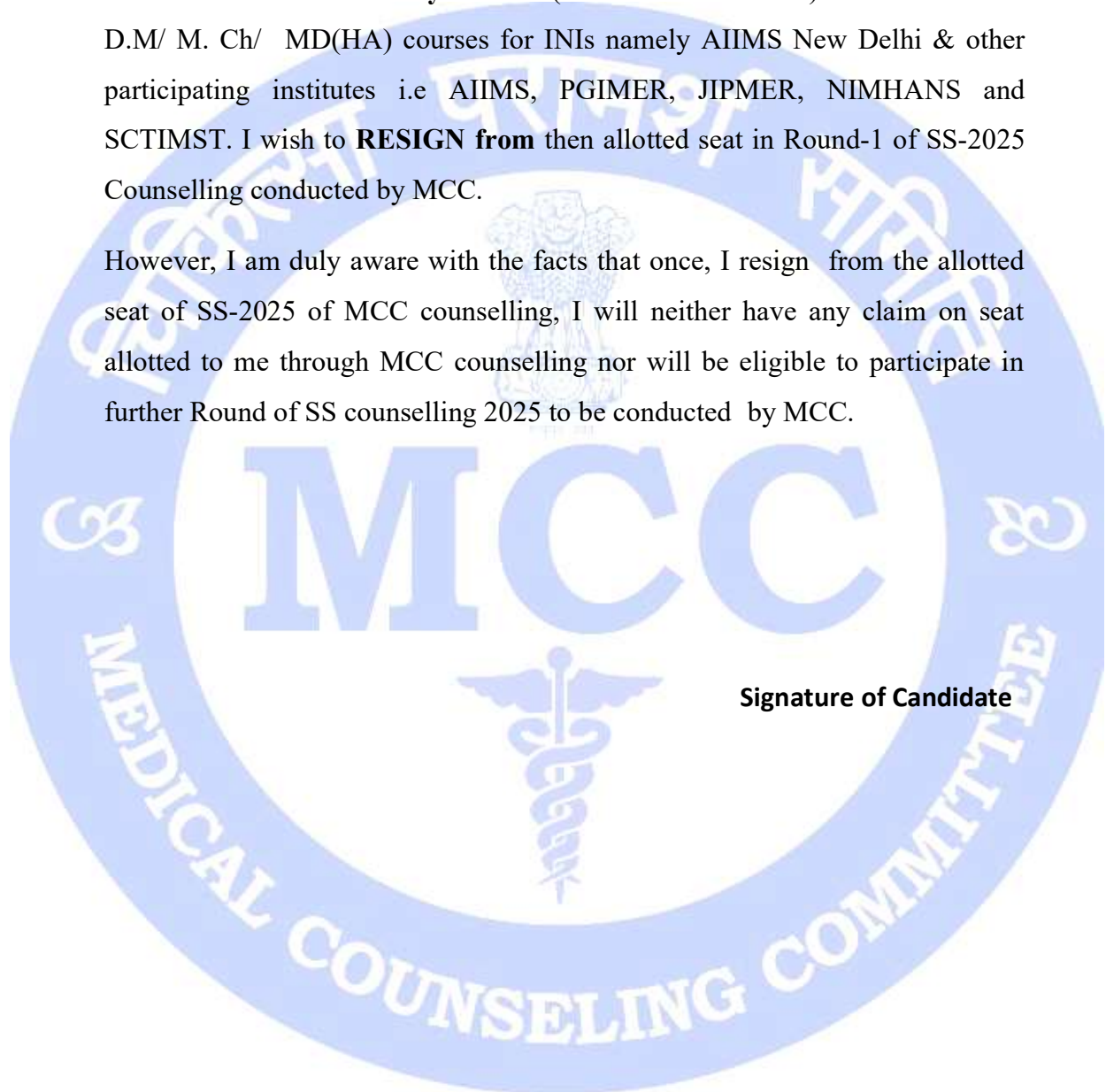
