ORDER

Sub: Imposition of monetary penalty at Lenora Institute of Dental Sciences, East Godavari District, (Andhra Pradesh)

Whereas, the Dental Assessment and Rating Board of National Dental Commission sought from Lenora Institute of Dental Sciences, Rajahmundry, (Andhra Pradesh), the valid MoU/Agreement and the exact road distance certificate in relation to the attached Medical College.

Whereas, the college submitted documents vide letter dated 21.05.2026 and later replied to the Show Cause Notice issued on 10.06.2026.

Whereas, it was found on record that during the periodic inspection held on 21-22.06.2024 at the college, the distance between the Medical College and the Dental College was recorded as **10 km**, whereas the later submitted distance certificate showed the distance as **13.485 km**.

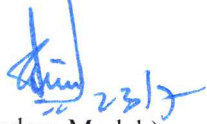
Whereas the college failed to place the correct factual position before the inspection team at the relevant time and furnished incomplete / incorrect information regarding material facts.

Now, therefore, in exercise of the powers conferred under Section 25(1)(f) of the National Dental Commission Act, 2023, the Dental Assessment and Rating Board hereby imposes a monetary penalty of Rs.1,00,00,000/- (Rupees One Crore only) upon Lenora Institute of Dental Sciences, Rajanagaram, Rajahmundry, East Godavari District, Andhra Pradesh, for furnishing incorrect and incomplete information, concealing material facts, and thereby misrepresenting the factual position before the inspection team and erstwhile DCI/NDC.

The institution is further directed to: (i) Deposit the aforesaid monetary penalty within 15 days from the date of issue of this Order; and (ii) Submit Proof of payment to the Dental Assessment and Rating Board, National Dental Commission within the stipulated period.

It is further informed that failure to comply with this Order shall invite further action under the provisions of the National Dental Commission Act, 2023.

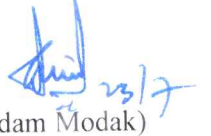
