- a) The admission for UG Course (MBBS) is tentatively scheduled from 18.08.2026 as per latest MCC notification.
- b) Venue for reporting for Admission - New Lecture Theatre.
- c) Documents Submission will start from 10:00 AM to 4:00 PM.

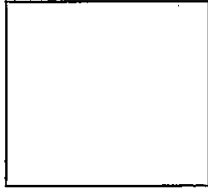

MAINTENANCE OF DISCIPLINE AMONG STUDENTS OF THE COLLEGE/UNIVERSITY

Without prejudice on the generally of power to enforce discipline under the Ordinance the following shall amount to acts of gross discipline:-

- a) Physical assault or threat to use physical force against any member of the teaching staff of any Institution/Department and against any student within the University of Delhi.
- b) Carrying of, use of or threat of use any weapons;
- c) Violation of the status, dignity and honour of students belonging to the scheduled castes and tribes
- d) Any violation of the provisions of the Civil Rights Protection Act, 1976;
- e) Any practice whether verbal or otherwise derogatory of women;
- f) Any attempt at bribing or corruption in any manner;
- g) Willful destruction of Institutional property;
- h) Creating ill-will or intolerance or religious or communal grounds
- i) Causing disruption in any manner of the academic functioning of the University system;
- j) Ragging as per ordinance XV (c)
- k) Consumption of alcohol or drugs chewing of tobaccos/Gutka/Pan/Pan Masala and smoking in the campus of college and associated hospitals;

The Dean may in the exercise of the power take the following actions against the defaulters:-

- a) Order or direct that any student or students be expelled; or
- b) Any student or students be, for a stated period rusticates; or
- c) be not, for a stated period, admitted to a course or courses of study in a college, deptt. or institution of the University; or
- d) be fine with a sum of Rs. _____ that may be specified ; or
- e) be debarred from taking a University or college or departmental exam. In which he/she or they/have appeared be cancelled.

I submit myself to the disciplinary jurisdiction of the Dean/Vice Chancellor and the several authorities of the College or University who may be vested with the authority to exercise discipline under the acts, the statues, the ordinance and the rules that have been framed there under by the University.
