Online Application forms are invited from the eligible candidates for admissions into Post Graduate Dental Degree/Diploma courses in Government and un-aided Private Non-Minority Dental Colleges under Competent Authority Quota seats for the academic year 2026-27 in the colleges affiliated to Dr. NTR University of Health Sciences.

2. Candidates are advised to visit the University website for all further notifications/latest updates/circulars/allotments on MDS Admissions till the closure of admissions. No individual communications will be sent.

- As per Memo No.2459247/C1/2024, HM&FW (C1) Dept., dt.20-07-2024 of Govt. of A.P., it is hereby clarified that all the 15% of the Unreserved seats in Medical/Dental colleges are now reserved exclusively for the Local candidates from the Andhra and Rayalaseema regions.
- As per G.O.Ms.No.95, dt. 20-07-2026 of HM & FW (C1) Dept., Govt. of A.P., the interim arrangements notified vide G.O.Ms.No.83, HM&FW (C1) Department, dated 23.07.2025 for the academic year 2026-27 the admission to 85% of the seats in each course in non-state wide institutions shall be reserved for the local candidates of Andhra Pradesh and the remaining 15% of the seats shall be un-reserved seats for the candidates of local/non local areas.
- As per Memo No.2825083/C1/2025 of HM&FW Dept., dt.23-05-2025 the reservations provided to the three groups of Scheduled Castes shall be within fifteen (15%) of reservation prescribed to Scheduled Castes as follows:-

- As per Memo No.2832690/C1/2025, dt.21-07-2025 of HM&FW (C1) Dept., Govt. of AP the Caste certificates issued by the Government of A.P will only be considered for admissions.
 - Latest Permanent caste certificate (Online issued by Competent Authority of Govt. of Andhra Pradesh only). Caste certificates of other States will not be accepted & in such cases the applied candidate will be considered under General category only.
