The Round 1 Draft Allotment List for UG NEET-based Professional Courses (M.B.B.S, B.D.S, B.A.M.S and B.V.Sc&AH - National SS & NRI) under Government, Management, NRI and Sports Quota is published on 02.09.2026 on the website www.centacpuducherry.in.

As per Notice Ref.No.CENTAC/UG-NEET/2026/11 dated 01.09.2026 of CENTAC, M.B.B.S. seats in Sri Venkateshwara Medical College Hospital and Research Centre and B.D.S. seats in Sri Venkateshwara Dental College have been excluded from Round 1 Draft Allotment.

NOTE:

The Candidates who have been allotted seats in JIPMER under "*Internal-Puducherry U.T. Domicile*" as per the MCC "*Provisional NEET-UG Counselling Seats Allotment-2026 Round 1*" and not furnished willingness to participate in CENTAC Counselling have been removed from the CENTAC First Round Draft Allotment List for UG-NEET Courses.

Using Dashboard login credentials, candidates can check the status of their allotment and submit objections, if any, using GRIEVANCES option in login dashboard before **11.00 a.m. on 03.09.2026**. After disposing the objections raised by the candidates if any, **Round 1 Provisional Allotment List** will be published.

The Candidates are further informed that the Draft Allotment List is only indicative in nature and subject to change. The candidates cannot claim any right over the allotted seat in the Draft Allotment List and the Draft Allotment List cannot be challenged before the Court of Law. The Candidates are advised to approach the allotted college / institute only after the publication of Provisional Allotment List and only after downloading the provisional allotment order from the Login Dashboard.
