1.	Date for fresh online registration/application and deposition of application and security deposit for fresh applicants alongwith fee of Rs. 5000+18%GST(Rs. 5900/-) and Rs. 2500+18% GST(Rs. 2950/- for SC candidates) through university payment portal. (Fresh registered candidates will have to submit willingness alongwith security deposit for Stray Vacancy Round.	01.10.2023 to 04.10.2023 (upto 03:00 PM)
2.	The last date for submitting willingness alongwith security deposit by all the candidates (already registered candidates and fresh applicants). The amount of security to be deposited for submitting willingness will be as under: For Government colleges - Rs. 10000/- (half for SC/BC) For both Govt. & Private Colleges – Rs. 1,00,000/- For Private Colleges – Rs. 1,00,000/- Note: The live vacant seat matrix will be displayed on the University website & Student Login Id	01.10.2023 to 04.10.2023 (upto 05:00 PM)
3.	Last date of correction/editing in online filled application form. Thereafter application will be locked automatically. Once information filled and locked, will not be allowed to change in any round of counselling. Note: Thereafter no request for change/amendment in the data will be accepted.	04.10.2023 (upto 03:00 PM)
4.	Last date for submitting admission application form for NRI quota (Application form for getting Eligibility certificate and admission application form for NRI candidates is separately available on University website)	04.10.2023 (upto 03:00 PM)
5.	The candidates who will apply under Sikh Minority/Christian Minority Quota will report to the respective minority institution (SGRD Institute of Dental Sciences, Amritsar / Christian Dental College, Ludhiana) for verification of minority status. The candidates who have already got verified their minority status at the time of 1 st , 2 nd & 3 rd counseling, need not report to the respective institute for verify again. The candidates who have already registered under Minority Quota during 1 st , 2 nd , 3 rd & Stray Vacancy Round counseling and did not get their minority status verified, can report to the respective institute for verification of their minority status for Stray Vacancy round of counseling.	04.10.2023 (upto 05:00 PM)
6.	Candidates who will submit willingness for 4th Round d including NRI candidates will fill/submit the online choices / preferences of college/Course/Quota/Category	05.10.2023 to 06.10.2023 (till midnight)
7.	Display of Provisional Merit List	05.10.2023
8.	Processing of seat allotment	Upto 07.10.2023
9.	Display of provisional allotment / Result	Upto 08.10.2023
10.	The provisionally selected candidates will pay the balance amount of fee (Six month fee after deducting amount of security deposit) through University Payment Gateway available on University website and will report to the respective college for joining in the respective allotted college.	Upto 11.10.2023

Note: If a candidate is allotted a seat in 4th round, he/she has to join the allotted seat/college. If the candidate does not join the allotted seat, he/she shall be debarred from NEET examination for 01 Year along with forfeiture of fees.

1 Q. No.1 - Whether Up-gradation is allowed in 4th Round counseling?

Ans. Upgradation is not allowed.

2 Q No: Who are not eligible for 4th Round?

2 Ans. Following categories of Candidates are not eligible:-

- Candidates who have not registered for 4th Round.
- Candidate joined/holding any seat at the time of 4th Round.
- Candidates allotted a seat in Round 3 & Stray Vacancy Round and NOT REPORTED/JOINED. All candidates not falling under above mentioned categories are eligible.
