INSTRUCTIONS FOR MD/ MS (AYURVED) & MD (HOMOEOPATHY) 4TH STRAY VACANCY (OFFLINE) ROUND OF COUNSELING

- Following candidates are eligible for 4th Stray Vacancy (Offline) Round,
 The candidates, who are included in the Merit-List of ACPPGMEC, irrespective of
 - (i) Allotment/Non-allotment of admission in 1st / 2nd /3rd Round of ACPPGMEC
 - (ii) Payment/Non-payment of tuition fees in Axis Bank in 1st / 2nd /3rd Round of ACPPGMEC
 - (iii) Reporting/Non-reporting at Help-Center in 1st / 2nd /3rd Round
 - (iv) Reporting/Non-reporting at admitted Institute in 1st / 2nd / 3rd Round of ACPPGMEC
 - (v) Cancelled/Non-cancelled admission of 1st/2nd/3rd of ACPPGMEC
- Following Candidates are not eligible for 4th Stray Vacancy (Offline) Round,

The candidates, who have secured admission in 15% AIQ/ Deemed/Central Universities MD/MS (Ayurveda)/ MD (Homoeopathy) seats of other state counseling and enlisted in Ministry Of AYUSH, New Delhi published the List of In-eligible candidates for participation in MD/MS (Ayurveda)/MD (Homoeopathy).

- It is mandatory for all the candidates, who want to participate in the 4th Stray Vacancy (Offline) Round, to give ONLINE CONSENT for participation in the 4th Stray Vacancy (Offline) Round.
- The candidate can take part in the 4th Stray Vacancy (Offline) Round without cancelling his admission of the previous rounds.
- To participate in the 4th Stray Vacancy (Offline) Round, the candidates have to log-in in the website http:// http://www.medadmgujarat.org/pgayus/home.aspx using their User-ID and Password to give ONLINE CONSENT from 15-03-2023, 6:00 pm to 18-03-2023 at 12.00 noon only.
- The student, who has not given online consent during stipulated time, will not be allowed to participate in the 4th Stray Vacancy (Offline) Round in any circumstances.
- After giving consent students have to take printout of "Consent" available in "Registration Details", which shows the date and time of consent given by him/her.
- Candidate has to remain present as per the merit rank on allotted date and time at "Lecture Hall No.-1,
 Ground Floor, GMERS Medical College, Gandhinagar". Students are instructed to bring copy of online
 consent at the time of offline counseling.
- All the candidates are instructed to see the number of vacant seats available for 4th Stray Vacancy (Offline) Round and closure of third round.
- The admission committee shall allot the seats as per available vacancy and also vacancy arise due to cascading effect of that particular seats.
- The candidates will be called as per the merit rank and will be allotted the admission on vacant seats as well as vacancy arises due to up gradation of seats during counseling. During 4th Stray Vacancy (Offline) Round of counseling, candidate will be offered seat as per the previous closure, vacancy and merit rank. If he is not willing to take admission in the offered seat, he can refuse the admission. In such case his/her

previous admission will remain as it is. If the candidate wants to cancel his/her admission of previous round, he/she can cancel it at the time of his/her 4th Stray Vacancy (Offline) Round of counseling. Tuition fees will be refunded at the end of whole admission process.

- In any circumstances no cancellation of seat for the candidate will be done after his/her 4th Stray Vacancy (Offline) Round counselling.
- Authority Letter or Proxy will NOT be allowed for taking admission in 4th Stray Vacancy (Offline) Round of counseling.
- The candidate, who have cancelled his/her admission of previous rounds or coming for fresh admission, are required to bring following original documents at the time of counseling,
 - a) All BAMS/BHMS marksheets
 - b) Internship completion certificate with specifying the 12 months' internship completion date i.e., on or before 31.12.2022
 - c) Copy of AIA-PGET-2022 Marksheet
 - d) Provisional / Permanent Registration of Gujarat Board of Ayurvedic & Unani System of Medicine OR Central Council of Indian medicine (with renewal)
 - e) Document showing place of birth & Date of Birth & Indian Citizenship (School leaving Certificate/ Transfer Certificate/ Passport/ Birth Certificate)
 - f) For SEBC, ST and SC Category: Cast certificate issued by Competent Authorities of Gujarat State only
 - g) *For SEBC Category:* Non-creamy layer certificate (Parishistha '4' in Gujarati/English) issued by Competent Authorities of **Gujarat State only** dated on or after 01/04/2020
 - h) *For EWS (Economically Weaker Sections) Category:* EWS certificate issued by Competent Authorities of **Gujarat State only**
 - i) Copy of Passport if Citizenship is Dual/Foreign
- The candidate, who have taken admission in previous round of ACPPGMEC, have to bring original admission order of ACPPGMEC and receipt of paid tuition fees
- The candidate, without original documents and prescribed fees, will not be granted admission under any circumstances.
- The candidate has to pay tuition fees / difference in tuition fees of one term (six months) by cash / Demand Draft in favor of "ACPUGMEC" payable at Gandhinagar at bank facility provided by Admission Committee, immediately. If candidate has paid tuition fees for admission for previous rounds, fees will be adjusted according to it. Excess fees will be refunded at the end of whole admission process.
- The candidate, who will remain absent at the day and time of counseling allotted to them, will have no right for admission.
