1. In view of ongoing COVID-19 outbreak and in compliance with the advisory issued by the Ministry of Health and Family Welfare, Government of India and instructions from Government of Gujarat, ACPPGMEC is going to organize 4th Stray Vacancy (offline) Round for Admission in Medical PG Courses through Video Conferencing at GMERS Medical College, Gandhinagar and 09 (Nine) Medical Colleges for the academic year (2021-22) only.

6. Candidate can select the Help Center (as mentioned above) for participating in 4th Stray Vacancy (offline) Round at the time of consent.
7. The student, who has not given online consent during stipulated time, will not be allowed to participate in the 4th Stray Vacancy (offline) round in any circumstances.
8. After giving consent students have to take printout of “Consent/Choice Form” available in “Registration Details”, which shows the date and time of consent given by him/her along with place for 4th Stray Vacancy (offline) Round.
9. Candidate has to remain present as per the merit rank on allotted date and time at **his/her Selected Help Center**. Candidate is instructed to bring copy of “Consent/Choice Form” at the time of offline counseling.
10. All the candidates are instructed to see the number of vacant seats available for 4th Stray Vacancy (offline) round and closure of previous round. The admission committee shall allot the seats as per available vacancy and also vacancy arise due to cascading effect of that particular seats.

11. The candidates will be called as per the merit rank and will be allotted the admission on vacant seats as well as vacancy arises due to up gradation of seats during counseling. During 4th Stray Vacancy (offline) round of counseling, candidate will be offered seat as per the previous closure, vacancy and merit rank. If he is not willing to take admission in the offered seat, he can refuse the admission. In such case his/her previous admission will remain as it is. If the candidate wants to cancel his/her admission of previous round, he/she can cancel it at the time of his/her 4th Stray Vacancy (offline) round of counseling. Tuition fees will be refunded at the end of whole admission process.
12. The candidate, who have cancelled his/her admission of previous rounds or coming for fresh admission, are required to bring following original documents at the time of counseling.
  - a) Consent/Choice Form for 4th Stray Vacancy (offline) Round
  - b) All MBBS attempt-wise Marksheets
  - c) 12 months internship completion certificate
  - d) Copy of NEET-PG-2021 Marksheets
  - e) Provisional Registration of State Medical Council OR Medical Council of India OR Permanent Registration of State Medical Council OR Medical Council of India
  - f) Document showing place of birth & Date of Birth & Indian Citizenship (School leaving Certificate/ Transfer Certificate/ Passport/ Birth Certificate)
  - g) For SEBC, ST and SC Category: Caste certificate issued by Competent Authorities of **Gujarat State only**
  - h) For SEBC Category: Non-creamy layer certificate (Parishista '4' in Gujarati/English) issued by Competent Authorities of **Gujarat State only** as per Govt. norms issued after Dt. 01/04/2019.
  - i) For EWS (Economically Weaker Sections) Category: EWS certificate issued by Competent Authorities of **Gujarat State only** issued after Dt. 01/04/2019
  - j) Copy of Passport - if Citizenship is Dual/ Foreign
  - k) Tuition Fees Consent: Take print of soft copy available on admission committee website and submit either in Gujarati or English.
  - l) Photocopy of Disability certificate issued by competent authority (if applicable)
  - m) Medical Fitness certificate
  - n) Any other document as per requirement
13. The candidate, who have taken admission in previous round of ACPPGMEC, have to bring original admission order of ACPPGMEC and receipt of paid tuition fees along with Consent/Choice Form for 4th Stray Vacancy (offline) Round.
- 14. The candidate, without original documents and prescribed fees, will not be granted admission under any circumstances.**
15. The candidate has to pay tuition fees / difference in tuition fees of one term (six months) by **cash / Demand Draft** in favor of "ACPUGMEC" payable at Gandhinagar at bank facility provided by Admission Committee, immediately. If candidate has paid tuition fees for admission for previous rounds, fees will be adjusted according to it. Excess fees will be refunded at the end of whole admission process.

16. If candidate wants to cancel his/her 1<sup>st</sup> /2<sup>nd</sup> /3<sup>rd</sup> round admission of PG MD/MS/Diploma, then he/she must have to give **CONSENT** to participate in 4<sup>th</sup> stray vacancy (offline) round. He/she can cancel his/her previous admission at his/her merit number turn on Date & Time specified in schedule of 4<sup>th</sup> stray vacancy (offline) round.
17. **In view of ongoing COVID- 19 outbreak, all the candidates are advised to pay tuition fees, preferably, by Demand Draft.**
18. The candidates are advised to come with specific arrangement of money to pay tuition fees at the time of counseling. The tuition fees of Govt. colleges are minimal, which can be paid by cash/DD, while fees of Management Quota seat of MD-Radiology at Pramukhswami Medical College, Karamsad is Rs. 25,00,000 (25 lakh) (for one term). So candidate can come with multiple Demand Drafts of Rs. 1,00,000/ 2,00,000/ 3,00,000/ 5,00,000/ 10,00,000 based on your choice of subject and college to secure admission in self-financed colleges.
19. **For NRI Candidate:** The candidate who has been allotted seat in NRI category, he/she has to pay Rs. 10.00 lakh (as Refundable Deposit) by cash or by Demand Draft in favor of **“ACPUGMEC” payable at Gandhinagar** at Bank facility provided by ACPPGMEC help center. After that student have to confirm the admission by submitting Original Documents at Help Center. Then candidate has to pay prescribed tuition fees in US Dollar or equivalent amount in any other currency at admitted institute. ACPPGMEC will refund the deposit amount of Rs. 10.00 lakh after the completion of whole admission process.
20. **According to Merit Closure Rule of PG Admission Rules, in 4th Stray vacancy (Offline) Round, the candidate will not be offered admission on the seats available according to his/her merit in allotment process during Previous rounds.**
21. Candidate of Reserved category (SEBC/SC/ST/EWS) **OR** special category (PH/NRI/In service) who get admitted/upgraded/retained admission at his/her category merit number at the time of category counselling of 4<sup>th</sup> stray vacancy (offline) round, will not be eligible to take part in his/her Open category turn of same 4<sup>th</sup> stray vacancy (offline) round.
22. **The candidate, who will remain absent at the day and time of counseling allotted to them, will have no right for admission.**
23. **The detailed schedule of 4th Stray Vacancy (offline) round (with date, time and merit no.) will be displayed on the websites ([www.medadmgujarat.org](http://www.medadmgujarat.org)) very soon.**
