## IMPORTANT INFORMATION FOR CANDIDATES PARTICIPATING IN

### OJEE COUNSELLING FOR MBBS/BDS COURSES

Candidates participating in OJEE Counselling for MBBS / BDS Course are advised to take note of the followings:

#### **1. PHYSICAL REPORTING AND PROVISIONAL ADMISSION OF 2<sup>ND</sup> ROUND COUNSELLING**

The 2<sup>nd</sup> Round allotment for MBBS/BDS courses has been published. Candidates are advised to download their Provisional Allotment Letter and take necessary action as per **OJEE / 571 dated 21.11.2022** (Schedule and Instructions for Physical Reporting and Provisional Admission of 2<sup>nd</sup> Round Counselling).

#### **2. WITHDRAWAL :**

The last date of withdrawal from OJEE counselling has been extended up to **24.11.2022 till 4.00 PM.**

#### **3. AUTO-UPGRADATION / SLIDING ROUND :**

- a. After completion of the provisional admission of 2<sup>nd</sup> Round of Counselling, basing on the unallotted, non-reported and withdrawal cases, an Auto-Upgradation / Sliding Round of counselling shall be conducted.
- b. Candidates, who have been placed in the Revised State Merit List (2<sup>nd</sup> Round) and still participating in OJEE counselling (either allotted or unallotted), shall be considered for auto-upgradation round based on their already filled choices in the 1<sup>st</sup> / 2<sup>nd</sup> round, provided they choose "FLOAT" option.
- c. **But candidates, who were allotted seats in 1<sup>st</sup> and 2<sup>nd</sup> round but not reported for provisional admission, shall get their allotments cancelled. They will go out of the system and will not be considered for the Auto-Upgradation Round.**
- d. If a candidate opts for 'float' for this round and is upgraded, then he/she has to accept the newly allotted seat and the seat allotted in the previous (2<sup>nd</sup>) round to him/her will be cancelled and will be allotted to other candidates as per merit.
- e. The allotment of Upgradation Round may be published on 26.11.2022 (tentative).
- f. **The candidates who have taken admission at the end of 2<sup>nd</sup> round of Central Counselling (All India Quota) are not eligible to participate in State Counselling. (As per NMC and Hon'ble Apex Court directives). Legal action / Penalty, besides cancellation of admission, as per the provisions, shall be initiated against any candidate doing so.**
