I am to state that for the Academic Year 2021-2022 Prospectus inviting application for the Bachelors of Naturopathy and Yogic Sciences (BNYS) course has been approved by Government vide ref. cited. As per the Prospectus Clause 17) iv) Seats have been earmarked in BNYS course for the nominee of the Government of India / Candidates from Deficient States / Union Territories; One seat in each of the Government Yoga and Naturopathy College, Chennai and International Institute of Yoga and Naturopathy Medical Sciences, Chengalpattu.

I am furnishing herewith a copy of the prospectus, Application Form and Notification for your perusal and to inform that the last date for applying for the course is 25.11.2021 till 05.30 pm. The softcopy can also be downloaded from the department's official website www.tnhealth.tn.gov.in till 25.11.2021, 05.00 p.m.

I am to state that Government of India is the nominating authority for the seat earmarked for the nominee of the Government of India / candidates from deficient states/Union Territories. I am to state that as per the Clause 17) iv): "Candidates applying against this seat should do so only through the application form issued by the Selection Committee, Directorate of Indian Medicine and Homoeopathy, Government of Tamil Nadu compulsorily. Candidates applying against this category (iv) should send the filled in application to the Ministry of AYUSH, New Delhi, Government of India, New Delhi through the Government of Union

Territory / Deficient State and one Self-attested copy of the application should be submitted in advance within the stipulated last date to the Secretary, Selection Committee, Directorate of Indian Medicine and Homoeopathy, Government of Tamil Nadu".

I request you to kindly nominate the candidate for admission to Bachelors of Naturopathy and Yogic Sciences (BNYS) course for the Academic Year 2021-2022 for the reserved seats within the stipulated date, i.e. on or before, 25.11.2021.

I am to inform that the tentative date of counselling for BNYS Course is proposed on 13.12.2021. During counseling Special Category seats will be filled up first followed by the general category seats. Hence, I request you to forward the nominated applications for the above special categories within the stipulated date; otherwise the seats earmarked for the above special categories will be brought into the General Category and will be filled up.

I am also to inform that the seat allotment and reservation to special categories is subject to the approval, affiliation and provision of seat matrices for the above colleges by the Tamil Nadu Dr. MGR Medical University.
