EDUCATIONAL NOTIFICATION

6(six) months Training of Ultra Sonography for Level 1 MBBS Doctors as per PC & PNDT Act, 2014 and rules at Agartala Govt. Medical College & GBP Hospital, Agartala for the 1<sup>st</sup> six months of the training for the year 2023 as per Guidelines/Rules/Procedure stated below:

1<sup>st</sup> session 2022 of USG Training to be started from January 2023.

**1) Introduction:**

Applications are invited from MBBS Doctors who have qualified in the NEET PG 2022 but not admitted to any PG course, for the 6 months Ultra Sonography Training namely "the fundamentals of Abdomino-Pelvic Ultra Sonography level 1 for MBBS Doctors at Agartala Govt. Medical College & GBP Hospital, Agartala

**2) Eligibility Criteria:**

- i. Permanent Resident of Tripura who have obtained MBBS Degree from any University of India duly recognized by MCI & have got registered with MCI/TSMC, level 1 for MBBS Doctors at Agartala Govt. Medical College & GBP Hospital, Agartala.
- ii. Candidates who are pursuing any other course are not eligible for admission to this course of USG training. However, candidates having completed the other course/resigning from the other course before the date of admission to this course of USG training will be eligible to get registration for the counselling/admission to this course of USG.
- iii. A candidate must qualify in the NEET PG 2022.
3. **Number of seats:** total 5(five) nos. Seats out of which 4(four) nos. For open category (Non-Service/In-service Non Sponsored candidates) (UR-02, SC-01, ST-01) and one of seat for in-service sponsored category (UR-01) (In the event of Non-availability of an open category (Non-Service/In-Service Non Sponsored) candidate, the seat will be distributed to In-service sponsored category candidate and vice versa but the category of UR/ST/SC shall remain the same).
4. **Mode of selection:** As per merit of NEET PG 2022 of different caste categories
5. **Selection procedure:** Candidate qualified in NEET PG 2022 only is eligible to apply; selection will be based on rank in merit list of NEET PG 2022 in the offline counselling of the registered candidates only.
6. **Fee structure:** The course fee is Rs. 10,000/- (Rupees ten thousand) only for open category, The In-service sponsored category is exempted from paying the course fee.
7. Registration fee is Rs. 1,000/- (rupees one thousand) only for all categories to be paid by Bank draft from any Nationalised Bank payable at Agartala in favour of Director of Medical Education, Govt. of Tripura.
8. The syllabus and course guidelines will be as per PC & PNDT Act, 2014
9. **Evaluation certificate:** On completion of 6(six) month training the candidates will have to appear for a competence based evaluation (final examination both theory and practical). On successful completion of the evaluation a certificate to the effect will be issued by Director of Medical Education, Govt. of Tripura, such certificate will be applicable for obtaining new registration/renewal under the PC & PNDT Act, 2014.
10. Reservation of seats as per Tripura State reservation act, 1991.
11. Period of training is for 6(six) months (the period of training shall be 300 clock hours. Candidates are requested see the Notification as per Gazette of India by Ministry of Health & Family Welfare, New Delhi dated, 9<sup>th</sup> January, 2014 regarding the short title & commencement, Nomenclature of six months training in USG etc.
12. Diversion from one category of another i.e. open to in-service or vice versa is not permissible once applied for particular category on application will be treated as final.
13. Eligible candidates either unemployed or in-service (permanent/ah-hoc) but not complete three years of specified rural service will be treated as open candidate (non sponsored). He /she is not eligible for the counselling of seat reserved for in-service category seat. No sponsored in-service candidate shall have to bring NOC from competent authority DHS candidates under TMES shall have to collect the NOC from DME.
14. In-service sponsored candidate of THS for the seat earmarked for in service sponsored candidate is one who at the time of application has completed three years rural service & submitted the sponsored certificate from competent authority/DHS.
15. Candidates shall have to submit all relevant documents in support of his/her statement submitted along with "Application Form" duly filled in.

16. Allotment/selection of seats will be done by the counselling committee and will be final.
17. A Bond of minimum 3 (three) years of service under the Government of Tripura after completion of the said training is applicable provided that he/she will be employed under the state government within six months after completion of the said training.
18. A candidate may be made free from bond obligation service immediately after the completion of the 6(six) month USG training course, if he/she gets an opportunity to an MCI recognised course is an MCI recognised Institution (with prior No-Objection from the DHS- in case of In-service candidate) for the period of course and following completion of the later course, the candidate shall have to serve total cumulative period adding the obligation service period of bond executed to the later course.
19. Bond will be applicable also to him/her if he/she discontinue his/her applied higher course.
20. The bond period will be of a sum of earlier bond period and subsequent bond period if any.
21. In the event of failure to serve under Government of Tripura for the bond period after successful completion of the 6(six) months training, he/she will have to pay an amount of Rs. 5.00(five lakh) only as a compensation/penalty and hand over the said amount to Government of Tripura.
22. Only the registered candidates applying with requisite fees and mandatory option for open or in-service category will be eligible for selection for the said training.
23. There will be no remuneration/stipend/TA/DA for the training course.
24. Accommodation may be provided from the concerned authority for the training course subjected to the availability of accommodation & the accommodation of so given to the candidates it will be as per rules & norms.
25. Age bar: Age of a candidate shall have to be below 45 (forty five) years as on 31.12.2022.
26. Selection of eligible candidates as per seat matrix shall be as per Merit of NEET PG 2022 exam, which will be done through offline counselling.
27. Candidates are hereby instructed to visit DME website (<https://dme.tripura.gov.in>) regularly for any further notice/Notification/updates.
28. Candidates are instructed to register their names submission of with application in the prescribed format with relevant documents with draft Registration fees at the office of the DME, Bidurkarta Chowuhani on or before 7<sup>th</sup> January, 2023.
29. Candidates are instructed to bring all original relevant documents or any leftover documents (during offline Registration) at the time of offline counselling for considering selection for admission to the course. The date of offline counselling will be declared shortly, where the aspirant eligible candidates shall have to be physically present with all relevant original documents.
30. Submission of any documents, papers or documentations of original after completion of the counselling of a particular candidate shall not be considered for any required eligibility.
31. Documents to be brought during counselling in original (1) Permanent Resident of Tripura certificate (PRTC), (2) MBBS Pass mark sheet, (3) Registration certificate of MCI/TSMC, (4) Internship Completion certificate, (5) NEET PG-2022 admit card and Score card, (6) Authentic Age proof certificate, (7) No objection certificate from DHS/Competent authority(In case In-service candidate), (8) Sponsorship certificate from appointing authority for In-service Sponsored category (9) Recent passport size photo 4(four) copies.
32. Please apply for registration in the prescribed "Application Form" (See Annexure-I) duly filled in with registration fees (Bank draft of Rs. 1,000/- rupees one thousand) only.
