Minutes of the Meeting held under the chairmanship of Ld. Vice-Chancellor, UHS, Rohtak in Committee Room, Vice Chancellor Secretariat on dated 24.11.2022 at 4.30 am for discussing the various issues related to the modified new MBBS Bond Policy.

The following decisions were taken unanimously by the members:-

At the outset, the chairman extended a warm welcome to all members and briefed the House about the agenda of the meeting. The issue of call of strike by Resident Doctors Association was discussed in detail and following deliberations were made:-

- The representative of Resident Doctors Association and agitating MBBS students were told that their strike cannot be justified on the ethical, legal and moral grounds, as it is infringing upon the right of patients to avail treatment facility at the State Apex Medical College Hospital [Action:- Resident Doctors Association and agitating MBBS students].
- The House including the Ld. Vice Chancellor, Director, Registrar, Dean, Medical Superintendent and
 members of student grievance committee appealed that in view of maintaining essential patient care
 services, the RDA should withdraw their strike immediately[Action:- Resident Doctors Association].
- Similarly, the representatives of agitating MBBS students were told in clear terms that they must
 withdraw their agitation immediately and only after that the negotiation regarding modifications in the
 terms and conditions of the New MBBS bond policy can be made [Action:- Agitating MBBS students].
- 4. The agitating students/ representative of RDA were clarified that in case the call of strike is not withdrawn, then the administration will be forced to impose strict administrative and legal measures for maintaining the continuity of essential hospital services [Action:- Resident Doctors Association and agitating MBBS students].
- 5. The demand of agitating students regarding withdrawal of FIR lodged against them was also discussed and they were informed that, if the strike is not withdrawn immediately, then the students who were involved in unlawful activities on 04.11.11 and FIR registered against them will not be withdrawn and necessary legal action will be taken against them by the law enforcing agencies as per the provisions of Indian Penal Code/Criminal Procedure Code. Also, the hostels will be got vacated within 24 hours from the students involved in strike [Action:- Dean, PGIMS, Rohtak].
- 6. The agitating MBBS students/ Representative of RDA informed the House that they will intimate about their decision regarding withdrawal of strike by tomorrow (before noon) after discussion with their colleagues [Action:- Resident Doctors Association and agitating MBBS students].
- 7. It was unanimously decided that all Hospital services like OPD, Indoor, OTs, Emergency & Lab facilities etc. will not be curtailed and will function as usual. All HODs/Unit Heads should ensure strict compliance and also persuade all resident doctors working under their administrative control to perform their duties as per duty roster [Action:- All HODs/Unit Heads, PGIMS, Rohtak].

The meeting ended with a vote of thanks to the chair.
