Provisional list of eligible/deficiencies/not eligible applicants for admission to Ph.D. Course: -

In context with the subject and reference cited above, I am directed to inform to all concerned that, on scrutiny of the documents of Ph.D. entrance test qualified applicant's received by the University for admission to Ph.D. Course for Academic Year 2022-23, the provisional list of eligible/not eligible and deficit documents applicants are hereby published by the University. All the concerned should note that, this is the provisional list of eligible / not eligible and deficit documents applications. These are likely to change as per clarification/queries/fulfilment of deficiencies received by the University from the applicants.

Under the said list, those applicants whose names have been considered in deficiency list, or those applicants who have not submitted hard copies of required documents yet to the University. All such applicants are hereby directed to submit the scan copies of these documents as mentioned against their name(s); in the said list before 'Discrepancy' column through the mail on email id **udc@muhs.ac.in** on or before 23/11/2022.

If any applicant has grievance/Objection regarding the provisional list, he/she should submit his/her grievance/Objection through the email on email id **udc@muhs.ac.in** along with scan copy of supporting documents up to 23/11/2022. The reserved category applicant if fails to submit documents required to claim benefits of reservation within given time, (i.e. up to 23/11/2022), then his / her application will be considered in open category and he/she has to pay fees as per open category applicant. Provided that, such applicant has to obtained at least 50% marks in Entrance Test.

Submission of online Choice of Centre preferences for Ph.D. Course: -

The provisionally eligible applicants (i.e. those who have qualified the Ph.D. entrance test) and applicants mentioned in the list of deficiencies (i.e. those who have qualified the Ph.D. entrance test but need to fulfil the deficiencies of the document) are instructed to submit their centres preferences in the subject of PET Exam through online mode only by clicking on the link below on or before 23/11/2022 at 23:59 Hrs. (midnight). Preferences submitted for the subject other than the PET subject, will not be considered. Before submitting the choice of preferences, applicants are advised to carefully go through the Seat matrix (Centre-wise & category wise seat position) and list of minority and women's colleges to know the details about the subject wise and Centre wise number of seats made available for admissions. Kindly note that, the applicants who have not qualified Ph.D. entrance test and those who have not submitted fine/penalty against the Unfair Means Cases, are out of the PhD admission process and they are not required to submit the preferences.

The final merit list and allotment of provisional admission letter for admission to Ph.D. course for academic year A.Y. 2022-23 will be published on University website shortly.

All the concerned applicants are instructed to visit the University website time to time.
