Medical College, Gaya, J.L.N.M.C., Bhagalpur, S.K.M.C., Muzaffarpur, IGIMS Medical College, Patna, VIMS, Pawapuri , G.M.C., Bettiah and S.H. Motihari, E. Champaran for the session 2021.
- MD / MS / PG Degree Courses in Private Medical Colleges viz. K.M.C., Katihar, Narayan Medical College & Hospital, Sasaram, M.G.M.M.C., Kishanganj for the session 2021.

3. The PGMAC - ID of reserve category candidates who competed in Unreserved category have been included in Unreserved (UR) as well as in their respective reserved categories. The seat of reserved category will remain open during the counselling of UR category and MRC candidates present in UR merit list will have option to opt UR seat as well as there category seat. **Therefore, Meritorius Reserve Category (MRC) candidates who are included in Unreserved Category must come for counselling on the date fixed at their Unreserved Category merit serial for option of course / institution available in Unreserved category as well as reserve category**, otherwise the reserved category seat available at their merit Serial may be opted and allotted to the candidate of lower merit for which be they themselves could be responsible.

4. Fresh MOP UP Counselling for vacant seats in Govt./ Private Medical Colleges of Bihar will be held off-line from 04.05.2022 to 06.05.2022.

5. The candidates participating in the Fresh Mop-up Counselling on scheduled date & time are advised to come prepared for staying next day, if needed.

6. The updated seat matrix for Fresh Mop-up counselling is available on Board's website: bceceboard.bihar.gov.in . The candidates are advised to see the vacancy before attending the counselling.

7. Inclusion of any PGMAC - ID in the above Counselling/ Interview programme does not guarantee admission. All candidates who have applied for Fresh MOP-UP Counselling in the light of Adv. No. BCECEB(PGMAC)-2021/15 & 2021/16 dated 28.04.2022 are being called for Counselling / Interview. Hence, if seats field up, counselling of concerned category will be postponed and then rest of the candidates have to return back.

8. All concerned above candidates will report at BCECE Board's office, IAS Bhawan, Near Patna Airport, Patna at the time of their slot given on his Rank Card. No candidate will be allowed to enter the premises before his / her slot time.

9. **The candidates who are admitted in any Govt. / Pvt. Medical institution either under All India Quota or State Quota or any other Medical institutions in India are not eligible for Fresh MOP UP Counselling.**

10. All eligible candidates have also to bring all required original documents and to show them at signature counter and to handover at entrance table of counselling hall other wise neither they shall be allowed to attend Fresh MOP UP Counselling nor will be given any time for producing original documents.

11. (a) **Each candidates who has opted seat and deposited security money of Rs.2,00,000/- (Two Lakh) during last Mop-up Counselling must come with Money Receipt provided by BCECE Board otherwise he/she will not be allowed to appear in Counselling.**

(b) **Each fresh candidate who were not allotted seat in last Mop-up Counselling and desirous of opting seats in any of above mentioned Private Medical Colleges, has to come with all required original documents and a Bank Draft of Rs.200000/- (Two lakh) only in favour of Controller of Examination, BCECE Board payable at Patna. If the candidate is allotted seat and doesn't take admission on his allotted seat, the deposited amount will be forfeited and in case of taking admission rest of the difference of fees have to deposit at the allotted institute. In such case the deposited security money of Rs. 2,00,000/- will be transferred to the concerned Institution other wise his/her deposit security money will be forfeited and admission will be cancelled.** The candidates have to show the bank draft at the time of giving his/ her attendance at attendance counter and have to submit the required bank draft and original certificates at the entrance gate of counselling hall otherwise he / she will not be allowed to participate in counselling.

(c) If the candidate is allotted a seat in Govt. Medical College he / she has to take admission within the prescribed time with deposit of full prescribed fee.

12. All terms and condition will remain same as in Adv. No. BCECEB(PGMAC)-2021/15 & 2021/16 dated 28.04.2022.
