- Candidates who are permanent employees of any Central/State Government/Armed Forces or the Public Sector Undertaking/Autonomous Body can be sponsored by the respective Government/Defence Authorities or the Competent Authorities of PSU/Autonomous Body.
- A State Government can sponsor candidates only for those Fellowship Programme which are not available in the State.

 A certificate

regarding non-availability of the Fellowship (for which the candidate is being sponsored) in the concerned State, duly signed by the Secretary/Director General of Health Services of the Central / State Government/ DGAFMS/Competent Authority or PSU/Autonomous Body viz. Director/Executive Head of the concerned organization, should be furnished in the format prescribed for this purpose.

- All eligible "sponsored" candidates will be called by the Institute for an entrance test.
- Seats as shown in the prospectus are available for "sponsored" candidates. Sponsored candidates will be designated as "Fellow".
- The subject for which the candidate is being sponsored should be clearly specified in the sponsorship form by the sponsoring authority. The candidate can be sponsored for only one subject. The applications of those candidates who are sponsored for more than one subject will not be considered.
- No "Sponsored" candidate will not pay any emoluments to the Institute during the training period. Such payments will be the responsibility of the sponsoring authority (i.e. Central/State Government or Defense Authorities).

In accordance with Minimum Qualifications for Teachers in Medical Institutions (Amendment) Regulations, 2018 reproduced as under:

"4A. Determination of equivalence of the qualification of DNB (Broad Specialities) with MD/MS & DNB (Super-Specialities) with DM/M.Ch.

- Those candidates who have undergone DNB training in an institution which now runs MCI recognized postgraduate degree courses in a given subject, their DNB qualifications shall be considered at par with MCI recognized qualifications in that subject only.
- Those candidates who have undergone DNB training in a multi-speciality teaching hospital with at least 500 beds, involved in various postgraduate/super-speciality teaching programmes provided that the one out of three DNB supervisors (teachers) qualify as postgraduate teacher as per MCI norms in his/her previous appointment; and one out of remaining two should qualify as postgraduate teacher as per MCI regulations with the following bed requirement for teaching unit:

Postgraduate Broad Specialities 30 beds per unit
Postgraduate Super Specialities 20 beds per unit

50% beds should be teaching beds.

Such qualification shall be considered at par with MCI-recognized qualifications.

- Those candidates who have three years teaching experience in the subject as Resident/Registrar/Demonstrator/ Tutor / or work experience gained during DNB training in both Broad Specialities and Super-Specialities course in other locations/institutions (100 or more bedded hospitals) shall work for one additional year as a senior resident in a MCI recognized/permitted institution for equivalence with MD/MS/DM/M.Ch.
- Those candidates who have three years of teaching experience in the subject as Resident/Registrar/Demonstrator/ Tutor / or work experience gained during DNB training or after possessing DNB qualification, in both Broad Specialities and Super Specialities course from an institution not covered in sub-clauses (a) to (c) shall work for two

additional years as Sr. Resident/Research Associate (CSIR) in an MCI recognised/permitted medical college/institution for equivalence with MD/MS/DM/M.Ch.

UPPER AGE LIMIT: NO UPPER AGE LIMIT.

(In-service candidates will have to apply through the proper channels and submit a "No Objection Certificate" from their employer along with their application forms. All eligible candidates seeking admission (Including in service) will have to appear in the entrance examination and go through the process of selection as envisaged for all).

<u>PAY SCALE:</u> ₹ 18,750 + 6,600 (Grade Pay) + NPA (Non-Practicing Allowance) plus other usual allowance or revised pay scale as per 7^{th} CPC as applicable (Level – 11 of the Matrix (Pre-revised PB – 3, entry pay of the ₹ 67,700/- per month + NPA plus other usual allowance admissible under rules).

The candidates must have completed the requisite qualification, degree, and tenure by 28.02.2024. The candidates who are likely to complete their requisite qualification, degree, and tenure after 28.02.2024 will not be eligible to appear in this examination.

COURSE FEES: The selected candidate has to pay the following fees on the day of admission:-

BOND: Candidates selected for Post-Doctoral Fellowship will execute a bond of ₹ 2,00,000/- (Two Lakh Rupees Only) on a Non-Judicial Stamp Paper of ₹ 100/- along with 2 sureties.

METHOD OF SELECTION:

The application of the candidates who will be received within the prescribed date and time and who submit the requisite fee will be scrutinized by the scrutiny committee of the Institute, and only the eligible candidates will be called for personal interview before the Selection Committee of the Institute. However, the same would be provisional subject to fulfilling all requirements, failing which he/she will not be allowed to appear for an interview. In case the number of applicants is large, the selection committee of the Institute may devise criteria for short-listing the candidates, which may include holding a written examination.

NO CANDIDATE SHOULD REGISTER MORE THAN ONE APPLICATION.
