- (iii) Period: PDCC This course will be of 12 months duration in July 2024 session (1st July 2024 to 31st July 2025).
- .(iv) The applicants who do not have requisite qualifications up to the date of publishing this notification in Institute website, will not be considered.
- (v) Incomplete application(s) will be summarily rejected.
- (vi) The period of experience wherever prescribed shall be counted after obtaining the prescribed educational qualification.

- (vii) The post(s) is/are whole time and private practice of any kind is prohibited.
- (xi) The candidates are likely to be posted at rural health and urban centre attached with the Institute for the period to be decided by the Institute as applicable.
- (x) AIIMS reserves the rights to increase or decrease the number of vacancies.
