**Sub:** American International Institute of Medical Sciences, Udaipur, Rajasthan, - under Rajasthan University of Health Sciences, Jaipur, Rajasthan- Letter of Permission was granted on 12<sup>th</sup> September, 2016 –1<sup>st</sup> renewal (2<sup>nd</sup> batch) and 2<sup>nd</sup> renewal (3<sup>rd</sup> batch) in the year 2017-18, 2018-19 were not granted; recognition- inspection was not done – A batch recognition was granted for 2016-17 batch on sworn affidavit dated 10.05.2021 - Surprise assessment on 24<sup>th</sup> February, 2022- major deficiencies -show cause notice – withdrawal of letter of permission, Cancellation of admissions into undergraduate and postgraduate courses for the academic year 2021-22 with effect from 18-04-2022 - regarding.

American International Institute of Medical Sciences, Udaipur, Rajasthan under Rajasthan University of Health Sciences, Jaipur, Rajasthan was issued Letter of Permission in the academic year 2016-17 for 150 MBBS Seats. LOP was issued on 12.09.2016. First renewal (i.e. 2<sup>nd</sup> Batch) and 2<sup>nd</sup> renewal (i.e. 3<sup>rd</sup> batch admissions) were not granted for the academic years 2016-17, 2017-18. The college has applied for Recognition of the 1<sup>st</sup> batch and Renewal permission for admission for 5<sup>th</sup> Batch (4<sup>th</sup> Renewal). Application for renewal of Permission and for recognition of MBBS Course was due in 2021-22 against annual intake of 150 MBBS seats. Admissions were granted based on Sworn Affidavit Dated 08.05.2021. The college has also applied for Postgraduate courses. MARB has given permission to postgraduate seats in Pathology, Obstetrics & Gynecology, Radio-Diagnosis, General Medicine, Ophthalmology, Bio-Chemistry, Community Medicine, Otorhinolaryngology, Pediatrics, Psychiatry, General Surgery, Anesthesiology, Forensic Medicine and Orthopedics for the academic year 2021-22.

The Medical Assessment & Rating Board of National Medical Commission has received several complaints on fake faculty and inadequate patients to provide hands on training. To verify the complaints a surprise assessment was conducted on 24<sup>th</sup> February 2022 u/s 26, 28 and 38 of the NMC Act, 2019, and found the following major deficiencies.

**Your explanations to the show-cause notice are not satisfactory.**

Following are the points to be considered.

Complaints are expected to be confidential. Surprise inspection is for the college both UG and PG and not just for the PG alone.

The college could have manipulated the staff and patients misleading the earlier inspection and hence one previous inspection being satisfactory does not explain such gross deficiency.

The dissent note by the principal does not explain the huge gap that exists between the expectation and the availability of staff and patients.

Faculty and senior resident including tutors have been projected for both UG and PG as per the old regulations. Still the magnitude of the deficiency is enormous over 50% deficiency (actually 55%). No explanation can explain the magnitude of the deficiency. The numbers have been taken from the attendance note also signed by the principal though with a dissent note.

\*Seven departments had no professor. In some departments there is excess in number (8; can be compensated for lower level positions in the total). Colleges explanation too indicates close to 30% deficiency which is substantial (page 6)

Actual bed occupancy claimed by the college is again not substantiated by the observations made by the assessors. Even the hospital records (HMIS), indicated 39% occupancy. The observed occupancy was 29%. It is impractical to check occupant of every bed and the case sheet's corroboration to establish the genuineness of the person on the bed. (To get PG seats, the college must have demonstrated 75% occupancy in earlier inspection/s). For a college running UG courses also PG training in Gynecology and obstetrics, mere two deliveries on the day is grossly insufficient.

**Explanation given to the gross in adequacy of clinical material in some of the departments as indicated is hence not satisfactory.**

At the time of the latest surprise inspection there was no reason to believe that the wards should have been kept vacant for the purposes of Covid. (for that matter, the Covid did not come in the way for 'filling' the beds in the previous 'surprise' inspection/s). Keeping such empty wards is detrimental to the training of not only undergraduates but the post graduates as well.

Together the deficiencies demand that the college should not admit either under graduates or post graduates for this academic year (21-22). Hence no UG/PG admissions be made for the academic year of 2021-22. If the students are already admitted, their admissions shall be cancelled with immediate effect and shall be transferred to other colleges.

**All the above deficiencies are major more than 50% and grossly inadequate with respect to the mandatory requirements of any medical college to permit the admissions for undergraduate and postgraduate courses. For further clarifications a table is enclosed in Annexure I.**

The teaching faculty and residents, technical staff deficiency in the college are significant and not as per the NMC guidelines. There is a gross deficiency of hospital services and lack of patients, out patients, in-patients, operation, deliveries and in emergency to train the students. The MARB of National Medical Commission has taken a serious note of the above mentioned deficiencies. On surprise assessment, as per the section 26 and 28 of the NMC

Act, 2019 in the college does not have minimum required faculty, residents and clinical material including the facilities required to run an undergraduate MBBS course.

After due deliberations, the explanation is not satisfactory and rejected. The MARB of NMC has decided to withdrawal of letter of permission, Cancellation of admissions into undergraduate 150 MBBS seats and postgraduate courses for the academic year 2021-22 with effect from 18-04-2022.

Further actions will be as per section 26 and 28 of the NMC Act, 2019.
