**ORDER**

In pursuance of the decision taken by the General Body of the Andhra Pradesh Medical Council, on 24<sup>th</sup> August, 2021, the same was communicated to the Respondent, – Verukonda Ravi Kiran vide letter dated 06-10-2021. The name of Dr. VERUKONDA RAVI KIRAN, bearing Registration Number APMC/FMR/100216 is removed from the Medical Register on 10th November, 2021 for a period of THREE MONTHS for violation of Provisions of Regulation 1.4.2 and 7.20 as a Photograph of the Sign Board of a Hospital depicting – Dr. V. Ravi Kiran, M.D. (Nephrology) on it, which is not only an “invalid degree” but also an “unrecognised qualification” as per Indian Medical Council Act, 1956, now National Medical Commission Act, 2019. He is directed to surrender his Original Registration Certificate bearing Registration Number APMC/FMR/100216 forthwith. In addition to the above, in pursuance of the said decision of the General Body of Andhra Pradesh Medical Council, he is liable for payment of **fine of Rupees Fifty Thousand (Rs.50,000/-) which he shall pay to the Council immediately** by way of Demand Draft obtained from any Nationalised Bank, favouring “Andhra Pradesh Medical Council” payable at Vijayawada.

It is hereby informed that the punishment, i.e. removal of his name from the Medical Register for a Period of Three Months commences from the date on which he surrenders his Original Certificate of Registration and make the payment of Fine amount as specified above.
