It has been brought to the notice of the undersigned that, Dr B.B.V.M.Mohana Rao, CAS, PHC, Makivalasa, Srikakulam has proceeded on un-authorized absence from duty w.e.f. 8-09-2020 onwards without prior permission from the competent authority.

2. Article of Charges have been framed against the individual vide reference 3rd cited with instructions to submit his written statement of defense, otherwise further action will be processed based on the material available. .
3. The District T.B.Control Officer, Srikakulam has been appointed as Inquiry officer to inquire into the charges framed against the above Delinquent officer, vide reference 5th cited .
4. The Inquiry officer has conducted Inquiry and submitted an Inquiry report besides submitting that the charges framed against him are proved vide reference 6th cited.
5. In view of the above, This office issued Show Cause Notice to the Delinquent Officer with a direction that, to submit her explanation within 15 days, from the date of publication of this notice as to why the penalty of termination from service shall not be imposed on him. The individual has not responded till date.
6. Therefore, after careful examination of the matter, Dr B.B.V.M.Mohana Rao, CAS, PHC, Makivalasa, Srikakulam is hereby terminated from his services from the date of his unauthorized absence from duty i.e., .w.e.f. 18-09-2020.
