UPON hearing the counsel the Court made the following O R D E R

1. The petitioner No.1-Srishti Nayak has not been permitted to participate in the selection process for seat in MBBS Course only for the reason that she did not have a recognized certification of having passed class 11th examination from a recognized school.

Mr. Gaurav Sharma, learned counsel appearing on behalf of National Medical Commission, says that the principal objection no Determined stands in view of the Graduate Medical Education Regulations, Research 2023. Learned counsel for the petitioner(s) states that the counseling has already taken place and a seat has already been allocated to the petitioner No.1-Srishti Nayak, as is evident from the document annexed at Annexure A-7 in the I.A. No.167616/2023.
Mr. Sunny Choudhary, learned counsel appearing on behalf of the State, shall verify the statement made by the learned counsel for the petitioner No.1-Srishti Nayak and inform us about it.

5. Let the matter be listed on 29.08.2023.

6. In the meanwhile, the seat which has been allocated to the petitioner No.1-Srishti Nayak, vide Allotment Letter (Provisional) (First Round: OPEN), Annexure A-7 in the I.A. No.167616/2023, shall not be withdrawn.
