**Notice for WB UG AYUSH Mop Up Counseling 2022 regarding**

The schedule for WB UG Mop Up AYUSH Counseling 2022 is published in counseling website [www.wbmcc.nic.in](http://www.wbmcc.nic.in) for public viewing.

The eligible candidate list shall be prepared by excluding the following:-

- A. Admitted candidates in WB UG Medical and Dental seats 2022
- B. Admitted candidates as per list provided by All India Counseling Authority in their website [www.mcc.nic.in](http://www.mcc.nic.in)
- C. Non eligible candidate list published by AACCC in their website
- D. Already remaining admitted candidates in WB UG AYUSH 2022 counseling after completion of Round 2 admission process.

Along with this, if any candidate is found to be remaining admitted in any other course, during the time of the admission process of WB UG AYUSH Mop Up 2022, such candidate shall not be allowed to get admission in the allotted college in Mop Up till he/she duly surrenders the previously admitted seat (if otherwise allowed for such surrender) and provides all the relevant original documents for admission process.

The seat matrix shall be provided after conversion of the remaining AIQ seats of the Private AYUSH colleges to the State Quota and providing the caste reservation as per policy of Govt. of West Bengal in such seats.

New registration is allowed for eligible candidates who have not registered yet.

The candidate/s who have not reported to the allotted seat in round 2 of WB UG AYUSH 2022 counseling, can take part in Mop Up round provided they are still eligible as per stated rule/s and provided they pay the counseling fee as penalty once again through their login.

If any candidate has not verified earlier after registration and fee payment, can do so during the document verification stage. The earlier acknowledgement slip would indicate the document verification venue.

There shall be fresh choice filling for all the eligible candidates for allotment consideration in the Mop Up Round. If any candidate, who is otherwise eligible, does not fill up the fresh choices and save and lock them, then the software cannot consider him/her for allotment purpose.





As there is possible seat conversion in Mop Up Round in case of actual vacancy arises and there is no such eligible candidate in that caste/category/PwD status to take such seat, then such seat may be considered for allotment as per conversion rule.

Accordingly candidates may be able to view virtual choices as well while choice filling. These choices can be filled and arranged by the eligible candidate in his/her choice basket as per sweet wish.

These choices shall only be considered for allotment when actual vacancies arise and actual seat conversion occurred as per rule during the Mop Up round allotment process.

The candidates are hence advised to fill up choices carefully and shall not get confused.

The documents that are verified at the verification venue, has to be again provided in original with one set self attested photocopy by the candidate if they are allotted, at the allotted institute for admission purpose. The original documents along with allotment letter are must for admission process along with the requisite college fee and bond within the schedule date/s as specified in the counseling schedule.

As 12<sup>th</sup> January 2023 is a State holiday, hence the last date of admission in Mop Up Round is pegged on 13<sup>th</sup> January 2023 as per server time.

If seats still remain vacant after the Mop Up Round, then the vacant seats, non allotted/non reported candidate list shall be published in due course along with the notice for Stray round/s in the counseling website [www.wbmcc.nic.in](http://www.wbmcc.nic.in)

The admitting colleges are requested to complete the online admission formalities within the specified time along with updating of such information in the requisite website please. One copy of admission slip shall have to be handed over to the eligible candidate after due authentication by the concerned college.
