| The fresh online registration/applications alongwith fee of Rs. 5900/- (Rs. 2950/- for SC candidates) including GST through university payment portal are invited through University website only from candidates who became now eligible as per notice of National Board of Examination in Medical Sciences, New Delhi dated 25.02.2025 vide which the qualifying percentile for admission under NEET PG-2024 is lowered/ revised upto 5th percentile for all categories. (Fresh registered candidates will have to submit willingness alongwith security deposit for Special Stray Vacancy online counseling, failing which their candidature will not be considered) | From 05.03.2025 to 06.03.2025 Upto 5.00PM |
| The dates for submitting willingness alongwith security deposit for Special Stray Vacancy Round of counselling by all the candidates (already registered candidates and fresh applicants). Note 1. The fresh registered PCMS in service candidates, who wants to avail incentive marks, will submit the NOC duly issued by the Secretary to Govt. of Punjab, Deptt. of Health and Family Welfare/competent authority, personally in the University **on 06.03.2025 by 5.00PM**. In case, NOC is not received in University, the candidate will not be considered for incentive marks. As the data for preparing merit list will be sent to NBE, New Delhi, therefore, no NOC will be accepted after this date.

2. Rest of the schedule of counseling will be made available through University website lateron.

Note: If a candidate is allotted a seat in Special Stray round, he has to join the allotted seat/college. If the candidate does not join the allotted seat, he/she shall be debarred from NEET examination for 01 Year along with forfeiture of fees.

Q. No.1 - Whether Up-gradation is allowed in Special Stray Vacancy Round counseling ?

Ans. Upgradation is not allowed.

Q.No.2: Who are not eligible for Special Stray Vacancy Round?

Ans. Following categories of Candidates are not eligible for Special Stray Vacancy Round:-

- Candidates who have not registered.
- Candidate joined/holding any seat at the time of Special Stray Vacancy Round.
- Candidates allotted a seat in Round 3 or Stray Vacancy and NOT REPORTED.

All candidates not falling under above-mentioned categories are eligible.

Note : The candidates who will be allotted seat by MCC in Special Stray Vacancy Round of All India Quota, will be debarred from Punjab State Special Stray Vacancy Round.
