Subject: NEET-PG 24(MD/MS/PGD) online registration of eligible candidates of J&K / Ladakh for preparation of Provisional Merit List (PML)-2024.

Consequent upon declaration of result by the National Board of Examinations in Medical Sciences (NBEMS) on 23rd August, 2024 for NEET PG-2024 and subsequently notified by the Board vide Notification No.112-BOPEE of 2024 dated: 18-09-2024, the candidates belonging to the UT of J&K / Ladakh who have qualified the NEET-PG as prescribed by the NBEMS, and whose names figure in the **Annexure "A"** of Notification No. 112-BOPEE of 2024 dated: 18-09-2024 and also the candidates whose names were not available in the said annexure but are the domiciles of J&K/ Ladakh and have submitted their documents in response to the aforementioned notification under reference forming **Annexure-A** to this Notification are hereby informed through the medium of this Notification to register themselves for 50% of UT quota seats of UT of J&K and upload the following documents online w.e.f **28-09-2024 to 02-10-2024 (mid-night)** so that Provisional UT Merit List (PUTML) of such eligible candidates belonging to UT of J&K/ Ladakh is prepared:-

(a) Important dates & Instructions:

- The online registration shall commence w.e.f. 28-09-2024;
- The last date of online registration shall be 02-10-2024 (Mid-night);
- The registration shall be made online through the BOPEE website www.jkbopee.gov.in.

(b) The cut off percentile for different categories is as under:

Category	Minimum Qualifying/Eligibility Criteria
Open Merit (including JKPM/CDP/ Sports/EWS)	50 th Percentile
SC/ST1/STII/OBC/ALC/IB/RBA(including JKPM/CDP/Sports)	40 th Percentile

(c) The candidates should upload the following documents:

- MBBS degree certificate;
- Registration with the State/ UT Medical Council/ MCI;
- Internship Completion Certificate (upto 15-08-2024 for MD/MS/PGD) courses.
- Domicile Certificate of UT of J&K or Ladakh as the case may be;
- Valid Reserved Category Certificate, wherever applicable, in terms of SO 176 of 2024 dated 15-03-2024 ;

- f) Difficult Area Certificate in pursuance of SRO 48 of 2018 dated 30-01-2018 to be certified by the concerned Director Health Services
- g) NEET-PG Score Card 2024
- h) NMC/MCI clearance certificate for candidates possessing MBBS degree from outside the country.
- i) Valid EWS certificate as per SRO 518 dated 02-09-2019.
- j) *NOC from Government/Competent Authority for in-service candidates to pursue MD/MS/PGD Courses-2024.
- k) For candidates belonging to UT of Ladakh, an undertaking in the form of compulsory Service Bond (available on BOPEE Website) that he/she shall serve in the UT of Ladakh for prescribed period immediately after completing MD/MS/PGD degrees.
- l) For candidates belonging to UT of Ladakh, their ST certificate issued by the competent authority shall be treated as Domicile Certificate.
- iv) The cut-off date for validity of the category certificates shall be the last date for Registration fixed by the BOPEE viz 02-10-2024.
- v) The candidates should register their particulars carefully.

****“In-service candidates” who have qualified NEET-PG-2024 and fall in the zone of consideration will be considered subject to issuance of “NOC” by the Competent Authority. Board may have NOC certificate verified from such authorities if it is found expedient to do so. However, they will be allowed to participate in the Registration/ Counselling process provisionally but will be allowed to join the allotted College/Institution on production of NOC only within the stipulated dates as fixed by the Board.

- vii) The e-Information Brochure and the Tentative Seat Matrix shall be uploaded on website of the Board separately in due course of time.

Note-1

Any candidate, who falls within the qualifying merit but has not registered himself/herself shall not be considered for counselling/allotment of seat under any circumstances or a candidate who has registered himself/herself but failed to upload the documents or have not uploaded all documents up to the prescribed date i.e. 02.10.2024 shall also not be considered for counselling/allotment of seat.

Note-2

The candidates shall have to fill the following fields correctly and as filled in the NEET-PG Application Form:

- a) NEET-PG Roll No as per Admit Card.
- b) NEET-PG 2024 (MD/MS/PGD) percentile score.
- c) NEET Rank.
- d) DOB.
- e) Valid Category, if any.

Note-3

- 1) Mere submission of Application Form and Registration of Candidates shall not confer any right on any candidate for admission, but it shall be subjected to the fulfilment of the Eligibility Criteria and the qualification prescribed for the said course and after check and verification of their documents at the time of admission by the College/ Institution authorities if the candidate(s) is provisionally selected.
