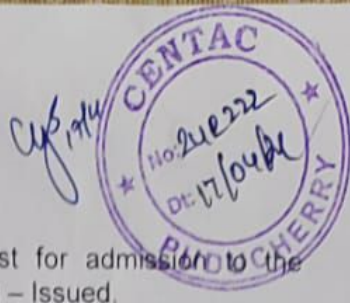

Chief Secretariat (Health) – Conduct of Common Entrance Test for admission to the B.Sc.(Nursing) Course in the Union Territory of Puducherry – Orders – Issued.

READ: Notification No.3 of 2024 dated 29.01.2024 of the Indian Nursing Council, New Delhi.

ORDER:

The Secretary, Indian Nursing Council, a statutory body under the Ministry of Health & Family Welfare, Government of India, New Delhi, vide Notification read above has intimated that the admission to B.Sc. (Nursing) from the academic year 2024-25 shall be made through Common Entrance Examination by the State Government Common Entrance Cell / Universities in compliance with the Indian Nursing Council (Revised Regulations and Curriculum for B.Sc. (Nursing) Programme), Regulations, 2020.

2. The Registrar, Pondicherry University has also informed this Administration to draw modalities relating to the admission of B.Sc.(Nursing) through entrance test.

3. Accordingly, the Hon'ble Lieutenant-Governor, Puducherry has accorded approval to conduct the Common Entrance Examination for B.Sc. (Nursing) Course from the Academic Year 2024-25 by the Board of Examination of Nurses (BOEN), Directorate of Health & Family Welfare Services, Puducherry for admission to the Pondicherry University affiliated colleges with the following stipulations:

- Entire Entrance Examination process shall be done by Board of Examination of Nurses, Puducherry in accordance with the directions of the Indian Nursing Council from time to time.
- Other terms & Conditions for Admission, Scheme of Examination, etc., will be intimated separately.
- The schedule for the Common Entrance Examination will be notified with the concurrence of the ECI on account of the Model Code of Conduct being in force.

4. The Deemed Universities in the Union Territory of Puducherry shall also conduct the said entrance exam at their level as per the directions of Indian Nursing Council, New Delhi.
