ALLOTMENT TO PG MEDICAL (DEGREE) COURSES, **KERALA-2025** **ONLINE OPTIONS INVITED**

The activities related to the first phase of centralized allotment for Post Graduate Medical Degree Courses for the year 2025 have commenced.

All the eligible Candidates included in the Kerala State Merit list who have applied for admission to PG Medical Courses 2025 in the State can register their options online through the website www.cee.kerala.gov.in before 12.11.2025, 5:00 PM.

Candidate shall have to click '**PG Medical 2025-Candidate Portal**' available in the above website and enter their Application Number and Password in order to access their home page. The Candidates can register their options online by clicking the menu '**Option Registration**' available in the home page.

The schedule for the allotment is given below:

06.11.2025	Opening of the option registration facility
12.11.2025, 5:00 PM	Closing of option registration facility

15.11.2025	Final Allotment
17.11.2025 to 20.11.2025, 4:00 PM	Joining at the allotted college

The list of Medical Colleges and Courses to which the Commissioner for Entrance Examinations makes allotments is provided on the candidate's home page. Candidates can submit their options according to their preference for Course-College-Quota combinations in the option list. **A candidate should give options for a Course-College-Quota combination only if he or she is certain to join the course and college under the chosen quota, if allotted. Only the options registered online will be considered for allotment to the courses.** Options sent to the Office of the Commissioner for Entrance Examinations by post, fax, or e-mail will not be processed or considered for allotment.

Candidates who seek admission under Minority/NRI quota in Self Financing Medical Colleges shall have to register options online to the desired courses/colleges in this first phase itself. Candidates who do not register options shall not be considered for allotment under Minority/NRI quota even if they are included in the respective category lists.

Candidates are requested to go through the relevant clauses in the Prospectus with regard to the Centralised Allotment Process before registering options.

Eligible candidates included in the Kerala State Merit List prepared by the Commissioner for Entrance Examinations (CEE) can register options in the first phase of counselling. Allotments will be made strictly on the basis of the options exercised, the rank obtained, and the eligible reservations of the candidate. Candidates should register options only for those courses and colleges they are certain to join upon allotment. A security deposit of ₹10,000 must be paid at the time of option registration. For SC/ST/OEC candidates and other candidates eligible for fee concession, the security deposit will be ₹5,000. The security deposit will be refunded to eligible candidates after the completion of the entire counselling process.

In the second phase of counselling, candidates will not have the facility for fresh option registration. Only confirmation, deletion, or rearrangement of the existing options from Phase 1 will be permitted. Option confirmation is mandatory to participate in Phase 2. Option registration will be available only for those courses that are newly added to the list in the second phase.

If a candidate is allotted a seat in the first phase and has joined the allotted college, his or her higher options will be retained, and all options below the allotted option will be automatically deleted, allowing only upgradation or

retention of the same seat. Candidates not joining the seat allotted in the first phase will have all of the registered options deleted and will therefore be left with no option to be carried forward to the second phase.

If a candidate who has joined a seat in Phase 1 does not confirm options in Phase 2, he or she will not be considered for upgradation in Phase 2; however, the seat joined in Phase 1, if any, will be retained. Therefore, if a candidate who joined in Phase 1 does not wish to be considered for upgradation in Phase 2, he or she may simply refrain from confirming options or delete all registered options.

Vacancies that exist or arise after the second phase of allotment will be filled in the third phase of allotment. **Fresh option registration will be available in the third Phase.**

After the third phase of allotment, any vacancies that exist or arise shall be filled through the stray vacancy allotment(s).

When a seat is allotted in a particular phase based on the valid options registered by the candidate, any previous admission, will stand cancelled, irrespective of whether the new allotment is accepted or not by the candidate.

3. Candidates whose positions in the Merit List have been withheld for various reasons may also register their online options for allotment. However, the options submitted by such candidates will be considered for allotment only if they rectify or clear the defects before **4:00 PM on 12.11.2025** and are otherwise found eligible.
