ADMISSION TO PG MEDICAL COURSES-2025
CENTRALISED ALLOTMENT-FIRST PHASE

PROVISIONAL LIST PUBLISHED

The Provisional allotment list for first phase of Centralised allotment to PG Medical Courses for the academic year 2025-26 in the Government Medical Colleges in the State, Regional Cancer Centre (RCC), Thiruvananthapuram and Private Self Financing medical colleges is published in the website **www.cee.kerala.gov.in**. The allotment is based on the rank in the Kerala State merit list published by Commissioner for Entrance Examinations and online options registered by the candidates within the stipulated time. The online options registered by candidates whose results have been withheld and of those candidates who have been disqualified based on the Kerala State Merit list have not been considered for allotment. The provisional allotment list is available on the website, www.cee.kerala.gov.in. Candidates can view the allotment list by clicking the menu '**Provisional Allotment List**'. In compliance with the interim order in WP(C) No. 35067 of 2025, one seat in General Surgery under the service quota of the Directorate of Medical Education has been reserved and, therefore, has not been included in this allotment.

Any discrepancy in the Allotment list may be informed to Commissioner for Entrance Examinations on or before 29.11.2025, 12.00 PM through the E mail ID: ceekinfo.cee@kerala.gov.in. Final allotment will be published after addressing genuine complaints, if any.

Note: *Candidates who have claimed SC/ST reservation and whose caste status is*

under scrutiny by KIRTADS have been provisionally considered for allotment. The allotment/admission, if any, of such candidates shall be purely provisional and subject to final verification of their caste status. Also those candidates, who have uploaded sworn affidavit of sponsor in case of memo for defect rectification in visa validity expired/expiring for NRI claim, have been included provisionally for first phase allotment. Their Allotment/admission in NRI quota seats, if any, will be cancelled if they fail to submit the document as prescribed within the stipulated time and will not be considered for NRI seats in further allotment.

The list of participating Medical Colleges in the allotment and the tuition fee applicable to each college have been given in the notification dated 06.11.2025 published on the website.

Candidates are informed that the provisional list is indicative in nature and is subject to change. Allotment to these colleges will be strictly provisional, subject to affiliation/recognition from the KUHS/Government. The allotment to colleges/courses will be subject to recognition of All India Regulatory Bodies/affiliation from the Universities concerned.
