ALLOTMENT/ADMISSION TO PG MEDICAL COURSES-2024

<u>Re-opening of application submission facility following lowering of the</u> <u>minimum qualifying percentile</u>

The NEET-PG-2024 minimum qualifying score has been lowered to the 5th percentile for all categories of candidates by the National Board of Examinations in Medical Sciences as per Notice dated 25.02.2025.

• The net vacancy after the Stray Vacancy Filling Allotment is published on the website. It is to be noted that all the seats in Government Medical Colleges, RCC Thiruvananthapuram have been filled through the previous allotments and also that no community reservation seats, NRI quota seats, seats reserved for PwD candidates and service quota seats are vacant in any of the Medical Colleges. However, any vacancy including such seats mentioned above that may arise during the counseling will be considered for allotment.

In order to enable the newly qualified candidates to participate in the remaining phases of the allotment process to fill the vacant seats in the Medical Colleges in the state, the online application submission facility for PG Medical-2024 courses has been reopened and will remain open till **04.03.2025**, **3:00** PM. All qualified candidates who have not registered earlier can also apply for PG Medical Courses using the opportunity.

The candidates should also satisfy all eligibility conditions as specified in Clause 4 of the prospectus.

Candidates can avail the application submission facility through the link **'PG Medical 2024 – Re-Opening Online Application'** on the website **www.cee.kerala.gov.in**, and should complete the online submission of the application and upload the required documents within the deadline. Those candidates who are eligible for any reservation (including the claims for Minority or NRI quota in self-financing Medical Colleges) or fee concession should upload the required certificates from the authorities concerned and all other valid and relevant documents in support of the claim.

Allotment of seats from the rank list for all courses in Self Financing Medical colleges will be made in accordance with orders of the Hon'ble Supreme Court of India /Hon'ble High Court of Kerala or the orders of the Government of Kerala/Government of India or as per the law in existence at the time of the Centralized Allotment Process (CAP).

Notification regarding option registration for allotment will be issued once MCC/NMC issued the schedule for counseling.

For more details regarding eligibility criteria, application fee etc., candidates are required to refer the Prospectus for PG Medical 2024 and Notification dated 30.09.2024. Candidates are advised to regularly visit the website of the Commissioner for Entrance Examinations for updates.
