Submission of Willingness, Payment, Declaration and Course Preferences

Both FRESH and EXISTING candidates may participate after submitting willingness, payment of Registration Fee and filling of Course preferences before 18/10/2024, 5.00 PM. If course preferences list is empty, the candidate will NOT be considered for allotment.

Further the candidate is requested to submit a Declaration form attached herewith as in Annexure-I.13 of PG-NEET MDS Brochure, failing which the candidate will NOT be considered for Allotment.

Refund / Forfeiture of Fees paid for Special Stray round

(i) In case the candidate is not allotted any seat, the Registration fee paid, will be refunded to the same account of the candidate from which payment had been made.

- (ii) Otherwise, if seat is allotted and the candidate does not join the course, the Registration fee amount will be forfeited and such candidate will be debarred from taking NEET exam next year.
- (iii) If candidates is ALLOTED a seat and joins the alloted seat the registration fee will be adjusted against the Tuition fee.
