**Stray Round Registration and Fresh Application for
PG DENTAL (MDS) for Vacancies under MANAGEMENT QUOTA**

PG DENTAL (MDS) vacancies under Management quota as on 05/09/2024 is published in CENTAC website.

Stray Round Registration for the vacancies published in CENTAC website for admission in PG Dental (MDS) courses is open. Using dashboard login credentials, candidates can **submit their willingness along with course preferences and payment of Registration Fees of Rs.50,000/- on or before 08/09/2024, 5.00pm** after referring to vacancy positions published in CENTAC website.

FRESH REGISTRATION FOR MANAGEMENT QUOTA

1. FRESH CANDIDATES OPTING FOR MANAGEMENT QUOTA

Online fresh applications are invited from NEET-MDS Qualified candidates for admission to the unfilled Management Quota Vacant Seats in Government and Private Dental Institutions, Puducherry.

2. EXISTING / APPLIED CANDIDATES OF CENTAC OPTING FOR MANAGEMENT QUOTA

Candidates who have already applied to CENTAC for PG NEET – MDS admission for Government quota ONLY may now submit willingness for Management quota after payment of balance application fees for admission to the MDS - Management Quota vacant seats. However, the candidates opting now will be considered only after exhausting the existing Management Quota merit list.

After exhausting the existing candidates in Management Quota merit list, FRESH candidates (including candidates who applied fresh in Round 3 will be considered for allotment).

Eligibility for registering Stray Vacancy Round

- 1. All candidates except those who are in admitted status in Round 3 (joined in Round 1 or Round 2 also) in All India Quota or State Quota are eligible for Stray Round.**

2. Candidates except those who have been allotted any seat in Round 3 or in any Stray round in All India Quota and either joined or not joined are eligible for Stray Round.

Submission of Willingness, Payment, Declaration and Course Preferences

Both FRESH and EXISTING candidates may participate after submitting willingness, payment of Registration Fee and filling of Course preferences before **08/09/2024, 5.00 PM**. If course preferences list is empty, the candidate will NOT be considered for allotment.

Further the candidate is requested to submit a Declaration Form attached herewith as in Annexure-I.13 of PG-NEET MDS Brochure, failing which the candidate will NOT be considered for Allotment.

Payment of Registration Fee:

The candidates are requested to transfer the registration fee to CENTAC account through NET BANKING or by generating NEFT / RTGS (preferably RTGS) challan using the payment link in their dashboard login credentials and proceed for payment. Read the HELP Instructions carefully before proceeding for payment.

Refund / Forfeiture of Fees paid for Stray round

- (i) In case the candidate is not allotted any seat during Stray round, the Registration fee paid, will be refunded to the same account of the candidate from which payment had been made.
- (ii) Otherwise, if seat is allotted and the candidate does not join the course, the Registration fee will be forfeited and such candidate will be debarred from taking NEET exam next year.
- (iii) If candidates is ALLOTTED a seat in STRAY round and joins the allotted seat, the registration fee will be adjusted against the Tuition fee.
- (iv) Therefore, it is advised that the candidate makes a thoughtful decision before submitting course preferences for Stray Vacancy Round.
