Stray Round Registration for PG MEDICAL (M.D. / M.S.) COURSES for Vacancies under GOVERNMENT / MANAGEMENT QUOTA

ROUND 3 admitted list and vacancy positions for PG Medical (M.D./M.S.) courses under Government and Management quota have been published on the CENTAC website <u>www.centacpuducherry.in</u>.

Stray Round Registration for the vacancies published in CENTAC website for admission in PG Medical (M.D./M.S.) courses is open. Using dashboard login credentials, candidates can **register** after referring to the vacancy positions published on the CENTAC website.

For **Stray Round admission** to the first year PG Medical (M.D./M.S.) courses in Government and Self Financing Medical colleges in the UT of Puducherry, submission of willingness, link for **payment of Full Tuition Fees as prescribed for** PG Medical (M.D./M.S.) and filling of Course Preferences under Government and Management (MQ) Quota will be enabled from **18.02.2025 to 22.02.2025, 5.00 pm.**

Eligibility for Registering for Stray Vacancy Round

All candidates EXCEPT

- 1. Candidates who are in admitted status in Round 3 (joined in Round 1 or Round 2 also) in All India Quota or State Quota.
- 2. Candidates who have been allotted any seat in Round 3 or in any Stray Round in All India Quota or State Quota but who have not joined.

Submission of Willingness, Payment, Declaration and Course Preferences

The candidates may participate after submitting willingness, payment of Full Tuition fees as applicable and filling of Course preferences before 22/02/2025, 5.00 PM. If course preferences list is empty, the candidate will NOT be considered for allotment.

Further the candidate is requested to submit a Declaration form attached herewith as in Annexure-I.10 of PG-NEET Brochure, failing which the candidate will NOT be considered for Allotment.

INSTRUCTIONS FOR PAYMENT OF REGISTRATION FEES

- 1. Candidates opting for PG Medical (M.D./M.S.) need to pay FULL TUITION FEE as mentioned below.
- Only those Candidates who pay the full Tuition Fee (SC / ST candidates registering for Government Quota should pay 25% of the Tuition Fees) will ONLY be considered for STRAY ROUND.
- 3. For those candidates who paid Registration Fee and were NOT allotted a seat in Round 3 need to pay the balance of Full Tuition Fee, as applicable, for Stray Round and submit course preferences.

PAYMENT OF FULL TUITION FEE

To participate in the STRAY ROUND counselling, the candidates are required to pay the Full Tuition Fee fixed as below:

** Reduced FEE structure for some of the Non-Clinical courses in Private Self-financing Colleges is published in CENTAC website. Therefore, the students are advised to make payments accordingly. The seat allotment will be done based ONLY on payment of FULL TUITION FEE for the respective courses in the STRAY Round.

The candidates are requested to transfer the registration fee to CENTAC account through NET BANKING or by generating NEFT / RTGS (preferably RTGS) challan using the payment link in their dashboard login credentials and proceed for payment. Read the HELP Instructions carefully before proceeding for payment.

Refund / Forfeiture of Fees paid for Stray Round

- (i) In case the candidate is not allotted any seat during the Stray Round, the Full Tuition Fee paid as applicable, will be refunded to the same account of the candidate from which payment had been made.
- (ii) Otherwise, if seat is allotted and the candidate does not join the course, the Full Tuition fee amount will be forfeited and such a candidate will be debarred from taking the NEET exam next year.
- (iii) If a candidate is ALLOTED a seat in the STRAY Round and joins the allotted seat, the fee paid will be adjusted against the Tuition fee, if any.
- (iv) Therefore, it is advised that the candidate makes a thoughtful decision before submitting course preferences for Stray vacancy counselling.
