**Special Stray Registration and
Fresh Application for
PG MEDICAL (M.D./M.S.) Vacancies in Self-financing colleges
under GOVERNMENT QUOTA / MANAGEMENT QUOTA**

Consequent to the Notice from the NBEMS, dated 25.02.2025, the Medical Counselling Committee has published the schedule for Special Stray Vacancy Round for admission to Post Graduate Medical (M.D./M.S.) courses and has extended the last date for admission up to 20.03.2025.

In view of above, Special Stray Round Registration for the vacancies published in the CENTAC website for admission to PG Medical (M.D./M.S.) courses is open. Using their dashboard login credentials, candidates can submit their willingness along with course preferences, and payment of applicable Tuition Fees on or before 14.03.2025, 5.00 p.m. after referring to the vacancy positions published in the CENTAC website.

PG Medical (M.D./M.S.) vacancies under Government Quota and Management Quota in PIMS, SMVMCH & SVMCH&RI as on 07/03/2025 is published in CENTAC website.

FRESH APPLICATION

Fresh Applications are also invited from NEET (PG) qualified candidates for admission to the first year PG MEDICAL (M.D./M.S.) (Government and Management Quota seats) for the Academic Year 2024-2025 against the vacancies published in CENTAC website. Interested candidates can apply online on or before 14.03.2025, 5.00 p.m. and submit willingness, declaration form and course preferences along with payment of applicable Tuition Fees.

Steps for registration for FRESH candidates:

Step 1: Fill the details, pay application fees and submit application.

Step 2 : Submit willingness and course preferences along with payment of applicable Tuition Fees.

Existing Candidates

Candidates who have already applied in CENTAC may submit willingness, declaration form and course preferences along with payment of applicable Tuition Fees on or before 14/03/2025, 5.00 pm.

Existing Government Quota candidates willing to opt for Management quota may update their willingness on their dashboard and submit willingness and course preferences. But the candidates newly opting for Management Quota will be considered as FRESH candidates in the Management Merit list.

After exhausting the existing candidates in the Government Quota and Management Quota merit lists, FRESH candidates will be considered for allotment.

Eligibility for Registering Special Stray Vacancy Round

1. All candidates who have been admitted in Round 1 / Round 2 / Round 3 / Stray round in All India Quota or State Quota are **NOT** eligible for Special Stray round.
2. Candidates who have been allotted any seat in Round 3 or in any Stray round in All India Quota or State Quota and who have either joined or not joined are **NOT** eligible to apply.
3. Candidates who are allotted a Seat through Special Stray Vacancy round of MCC will not be considered for this round.

Submission of willingness, declaration form and course preferences

Both FRESH and EXISTING candidates may participate after submitting willingness, payment of Tuition Fee and filling of Course preferences before 14.03.2025, 5.00 PM. If course preferences list is empty, the candidate will NOT be considered for allotment.

Further, the candidate is requested to submit a Declaration Form attached herewith as in Annexure-I.10 of PG-NEET Brochure, failing which the candidate will NOT be considered for allotment.

INSTRUCTIONS FOR PAYMENT OF FEES

1. Candidates opting for PG Medical (M.D./M.S.) courses in this SPECIAL STRAY ROUND, need to pay FULL TUITION FEE as mentioned below. ONLY those Candidates who pay the full Tuition Fee will be considered (SC / ST candidates registering for Government Quota should pay 25% of the Tuition Fees).
2. Those candidates who have paid Registration Fee and were NOT allotted a seat in Round 3 / Stray Round, need to pay the balance of the Full Tuition Fee, as applicable, for Special Stray Round and submit course preferences.

PAYMENT OF FULL TUITION FEE

To participate in the SPECIAL STRAY ROUND counselling, candidates are required to pay the Full Tuition Fee fixed as below:

******Reduced FEE structure for some of the Non-Clinical courses in Private Self-financing Colleges is published in CENTAC website. Therefore, the students are advised to make payments accordingly. **The seat allotment will be done ONLY based on payment of FULL TUITION FEE for the respective courses in the SPECIAL STRAY ROUND.**

Candidates are requested to transfer the Registration Fee to the CENTAC account through NET BANKING or by generating NEFT / RTGS (preferably RTGS) challan using the payment link in their dashboard and proceed for payment. Read the HELP Instructions carefully before proceeding for payment.

Refund / Forfeiture of Fees paid for Special Stray Round

- (i) In case, the candidate is not allotted any seat in the Special Stray round, the Tuition Fee paid, will be refunded to the same account of the candidate from which payment had been made.
- (ii) However, if a seat is allotted and the candidate does not join the course, the entire Tuition Fee amount will be forfeited, and such a candidate will be debarred from taking the NEET exam next year.
- (iii) Therefore, it is advised that the candidate makes a thoughtful decision before submitting course preferences for Special Stray vacancy counselling.
