Continuation / Extension of Affiliation for Academic Year 2023-24...

Ref. University Direction No. 02/2016 dated 13/12/2016,

It is notified to all concerned that University has initiated the process of Continuation of Affiliation / Extension of Affiliation (if applicable) of affiliated PG Medical Institutes for Academic Accordingly, the University has finalised Local Inquiry Committee (LIC) Year 2023-24. (Part-I: Inspection Format & Part-II: PG Medical Institute Information) Proforma for inspections, which is attached herewith for information & necessary action.

The Institutes are required to go through LIC's Inspection Proforma and shall fill-up requisite information including all Annexures for verification of LIC Team. As instructed earlier during inspections for A.Y.2022-23, the Institutes have created the "MUHS Mandate" tab on homepage of the Institute website. It is mandatory for the Institutes to upload Information of all Annexure's on Institute website and the information should be kept Year-wise & Annexure-wise for a period of 05 years.

The University has taken up paperless initiative and gearing up for Online Transmission of Question Papers and Onscreen Evaluation of Answer Books. However, the Institute is required to submit hard copies of few Annexures viz. Annexures I, II, III, IV, V, VI & VII to the University. Copies of rest of the Annexures are required to be uploaded on respective Institutes Website.

It is mandatory for the Institute to maintain infrastructure, teaching staff and other requirements as per MSR throughout the year; failing which affiliation granted shall be revoked by the University at any stage.

The Dean / Principal of the Institute is required to update Institute website as well as keep information ready for verification of the LIC Team; the inspection shall commence from 15/02/2023 onwards. It is notified that the Institutes, who fails to update their information on College/Institute website, shall not be granted affiliation.
