THIS WRIT PETITION IS FILED UNDER ARTICLES 226 & 227 OF THE CONSTITUTION OF INDIA PRAYING TO HOLD AND DECLARE THAT THE COMMON JUDGMENT DATED 30.8.2019 PASSED BY THE LEARNED JUDGE IN WP NO.40566/2015 AND CONNECTED MATTERS IS NOT BINDING ON THE PETITIONERS HEREIN WHO ARE ALL POST GRADUATES DEGREE AND DIPLOMA HOLDERS FALLING UNDER THE PRIVATE/ MANAGEMENT/NRI CATEGORY OF THE 2018-19 BATCH OF CANDIDATES SINCE THE NOTICE TO PERFORM COMPULSORY SERVICE UNDER THE KARNATAKA COMPULSORY SERVICE TRAINING BY CANDIDATES COMPLETED MEDICAL COURSE ACT, 2012 AS AMENDED BY ACT 35 OF 2017, IN THE INFORMATION BULLETIN/BROCHURE OF 2018-19 AND THE BONDS OBTAINED FROM THEM ARE BAD IN THE EYE OF LAW AND NON EST, AS THE SAME WERE OBTAINED FROM THE PETITIONERS DURING THE SUBSISTENCE OF THE STAY ORDER OF THE HIGH COURT STAYING THE SAID ACT AND ALL PROCEEDINGS PURSUANT THERETO AND ETC.

THESE WRIT PETITIONS ARE HAVING BEEN HEARD AND RESERVED ON 26.02.2021 AND COMING ON FOR PRONOUNCEMENT OF ORDERS, THIS DAY, THE COURT MADE THE FOLLOWING:

COMMON ORDER

The petitioners in W.P.Nos.15481/2020, 745/2021 and 830/2021 are Post Graduate medical students/students who have completed the PG Medical Course having joined the course during the academic years 2016-17 and 2017-18. The petitioners in W.P.Nos.1143/2021 and 858/2021 are Post Graduate Diploma students/students who have completed the PG Diploma course having joined the course during the academic years 2018-19. Their grievance in common is that the provisions of "Karnataka Compulsory Service Training by Candidates Completed Medical Courses Act, 2012" are made applicable to the petitioners and consequently the impugned order dated 23.07.2020 has been issued calling upon the petitioners who would be graduating from various institutions in the State of Karnataka to report to the Director of Medical Education after the exams, for posting. The Head of the institutions are directed to inform the students to report at the office of the Director of Medical Education.

2. Since the challenge raised in all these writ petitions are common, the matters were heard together and these writ petitions are disposed of by this common order.

3. The Karnataka Compulsory Service Training by Candidates Completed Medical Courses Act, 2012 (for short 'the Act 2012') was gazetted on 24.07.2015 as Karnataka Act No.26 of 2015. The avowed purpose of the enactment was for providing compulsory service by candidates who had completed medical courses, before award of degrees or post graduate degrees or diplomas. When the original Bill was promulgated, the stated purpose was to ensure availability of rural service training in Government Primary Health Centers and Government Hospitals. The Act having been reserved for the assent of the President of India under Article 254 (2) of the Constitution received the assent of the President. A spate of challenge were raised to the Statute and by interim order dated 06.10.2015 in W.P.No.40566/2015 and connected matters, this Court stayed the operation of the Principal Act along with all further proceedings, orders, actions, notifications including the Rules etc., pursuant to the Act. Degree certificates were directed to be issued to the students, however they were made subject to result of the writ petitions, with an undertaking that if the writ petitions fail, the petitioners would comply with the provisions of the Act. The State Legislature, presumably, taking

note of the contentions in the writ petitions, amended and omitted the words "training" and "trainee" from the Principal Act, except in sub-section (4) of Section 3, by virtue of the Karnataka Act No.35 of 2017. The amendment also removed the embargo on the grant of degree and temporary registration under the provisions of the Karnataka Medical Registration Act, 1961. Nevertheless, the challenge raised in the said writ petitions continued and the writ petitions were disposed of by order dated 30.08.2019, upholding the provisions of the Act and the Rules. However, it was held that the provisions of the Act and the Rules were prospective in nature and therefore they do not apply to the students who had already been admitted to the respective medical courses, i.e., Graduation, Post Graduation or Super Specialty Courses before 24.07.2015, the date on which the Karnataka Act No.26 of 2015 came into force.

4. Some of the petitioners herein approached the Division Bench in W.A.Nos.483/2020 and connected matters, calling in question the order passed by the co-ordinate bench. The Division Bench noticed that the appellants were not parties to the proceedings in W.P.No.3645 of 2016 and connected matters. It was therefore held that the petitioners in W.P.No.3645/2016 had

received certain relief at the hands of the learned single judge and in the absence of those petitioners, if the order dated 30.08.2019 is set aside, it would only affect the petitioners in those writ petitions and that too without giving an opportunity of being heard. Therefore, it was held that the upholding of the validity of the Act or Rules being an order or judgment in *rem*, but the particular reliefs granted to the writ petitions or parties in the writ petition would have to be looked into. Moreover, it was noticed that other than setting aside the order dated 30.08.2019, the appellants had not sought for consequential reliefs in the appeals. Therefore, it was held that setting aside the order of the learned single judge would not enure to the benefit of the appellants. Consequently, the writ appeals were disposed of reserving liberty to the appellants therein to file writ petitions assailing the validity of the Act and the Rules having regard to their status and position vis-à-vis the Act and the Rules. In terms of the liberty granted by the Division Bench, these writ petitions are filed. By way of interim directions, the petitioners were protected from implementation of the provisions of the Act.

5. Though the learned counsel for the petitioners made submissions attacking the validity and vires of the Act and the

Rules, this Court made it clear that the declaration made by the co-ordinate bench upholding the validity of the Act and the Rules is an order/judgment in *rem*, as rightly pointed out by the Hon'ble Division Bench. Therefore, this Court shall not be persuaded to hold a contrary opinion. Moreover, the prayers made in these writ petitions are to declare that the provisions of the Act and the Rules are not binding on Post Graduate Degree and Diploma holders who were admitted during the academic years 2016-17, 2017-18 and 2018-19. Although, it is contended that the provisions of the Act and Rules are not applicable to the Private/Management/NRI category students, this Court is of the opinion that the said issue having been considered by the co-ordinate bench holding that the provisions are applicable to the Private/Management/NRI category students, the issue will not be gone into. Therefore, what requires to be considered is whether the provisions of the Act and Rules could be applied to the students who were admitted to the courses during the years 2016-17, 2017-18 and 2018-19.

6. The contention of the petitioners is that the amendment Act 35 of 2017 was brought into effect from 11.07.2017. Whereas, the Department of Medical Education, in association with the

Karnataka Examinations Authority had issued the information bulletin for admission to Post Graduate Degree/ Diploma Medical and Dental Courses for the academic year 2017-18 much earlier to the said date. In fact, it is urged that for the first time the National Entrance and Eligibility Test (NEET) was held for the academic year 2017-18. Three brochures were issued, separately with respect to Government quota students, Combined Centralised Counseling and NRI/Management seats. While taking this Court through the brochures, it was submitted that none of the three brochures contained the requirement of compulsory service in terms of the Act, 2012. Most importantly, it is submitted that the process of admission, as directed by the Hon'ble Supreme Court, was completed by 31.05.2017.

7. The learned counsel for the petitioners submitted that the brochures, from the year 2015-16 contained the provision for compulsory service as stipulated in the Karnataka Conduct of Entrance Test for Selection and Admission to the Post Graduate Medical and Dental Degree and Diploma Courses Rules, 2006 (for short 'the Rules, 2006'). In this regard, the learned counsel while placing reliance on a decision of the Hon'ble Apex Court in the case

of ***Parmender Kumar and Others vs. State of Haryana and others (2012) 1 SCC 177***, submitted that if the students are not made known about the conditions and covenants for issuance of the degree certificates, the State authorities are precluded from imposing such conditions and denying the certificates on the ground of non-compliance. It is contended that the requirement of Compulsory Rural Service in terms of the Rules, 2006 is contained in the brochures, consequent to which bonds were taken from the Government Quota Students. It is therefore contended that these restrictions are required to be made known to the students who come from various parts of the country and foreign countries. If such conditions and restrictions are made known to the students before hand, they will be in a position to decide as to whether they would be in a position to comply with the conditions. Such of the students who would not like to be compelled or who are not in a position, for various reasons, to fulfill the conditions, may opt out of the admission process. In otherwords, it is submitted that the petitioners having not been informed of the application of the provisions of the Act and the Rules, the provisions cannot be made applicable to them.

8. It is further contended that in the Karnataka State Information Bulletin for 2018-19, information is provided and the students are put on notice that after completion of the Course they shall undergo one year compulsory service in Government Hospital in urban area as per the Act, 2012 as amended on 22.09.2017 and Rules thereunder. It was informed that the students are entitled to only temporary registration till completion of such service. At Annexure '4' the format of the Bond to be executed is also provided and the students have executed the bonds. Similarly in the Karnataka State Information Bulletin NEET-PG for 2019, such information is provided and students were put on notice, consequently, the students have executed the bonds. Same is the situation in respect of the Information Bulletin-NEET-PG for 2020. However, in the Information Bulletin PGET-2015 and 2016, such information is not provided and consequently, no bonds have been taken from the students. Similarly, in the three Information Bulletins for the PGET 2017-18, in respect of Government quota students, combined centralized counseling and NRI/Management seats, no such information regarding implementation of the provisions of the Act, 2012 is provided and no bonds have been

executed by the students. On the other hand, the students were duly notified of compulsory service for three years in terms of Rules, 2006, applicable to the Government quota students.

9. Per contra, the learned Additional Advocate General Sri R.Subramanya, submits that merely because the information is not provided in the Information Bulletin, that by itself will not preclude the Government from implementing the provisions of the enactment. It is submitted that it is by now well established that ignorance of law cannot be an excuse. The State Government having enacted the law and the law having received the assent of the President of India, the provisions shall be implemented. As regards the decisions cited by the learned Counsel for petitioners, including the case of **Parmendar Kumar** (supra), it is submitted that the terms and conditions governing the eligibility of the students, holding of examinations and counseling for admissions have to be scrupulously followed by the examination authority and the State Government. However, insofar as the information provided to the students regarding compulsory service cannot be treated as mandatory requirement. It is submitted that such information is provided as a matter of precaution and non-providing

of such information in the Information Bulletin cannot be a reason for non-implementation of the provisions of the statute. It is submitted that the brochures have no force of law when the Act has been framed and published.

10. Certain factual information was also provided by the learned Additional Advocate General. It is stated in the information that out of a total number of 2,629 students who have completed the course, 784 have reported for duty. This information is strongly objected to by the petitioners stating that it does not give the full picture. It is contended at the hands of the petitioners that the State Government has admitted before this Court in the case of

Dr.Swamy Manjunath S.T. And Ors. Vs. The State of

Karnataka & Ors., in W.P.Nos.46917-47025/2018 and connected matters decided on 21.12.2018 that even in respect of Government quota students who had executed bonds undertaking compulsory rural service in terms of Rules, 2006, the State Government was not able to enforce the bonds. It is on record that the State Government has approached the Civil Court to recover an amount of Rs.258 crores for violation of the bonds. It is therefore submitted at the hands of the petitioners that had the State

Government implemented the provisions of the Rules, 2006, there was no need for enacting a new law compelling the Management quota students to undergo compulsory service.

11. Heard the learned Counsels and perused the petition papers.

12. As stated earlier, although grounds are raised and submissions were made at the hands of the petitioners regarding the validity of the Act, this Court is not persuaded to reconsider the issue. The co-ordinate Bench, while upholding the validity of the Act and the Rules, held that the provisions of the Act and the Rules are prospective in nature and therefore, they do not apply to the students who had already been admitted to the respective Medical courses before 24.07.2015, the date on which the Karnataka Act No.26 of 2015 came into force. Therefore, the consideration in these writ petitions will only be as to whether the provisions of the Act and the Rules are applicable to the petitioners who were admitted to the PG Medical Course and PG Diploma Course during the academic years 2016-17, 2017-18 and 2018-19.

13. It is an admitted fact that the Amendment Act 35 of 2017 was brought into effect from 11.07.2017. It is also an

admitted fact that in terms of the directions of the Hon'ble Supreme Court, the process of admission to the PG courses of the academic year 2017-18 was completed on or before 31.05.2017. The State Government has not disputed the fact that the aspirants of seats for PG courses for the academic year 2017-18 or the Courses prior to 2017-18 were not required to execute bonds undertaking compulsory service in terms of the Act, 2012.

14. On the other hand, during the course of the proceedings in the case of ***Ms. Bushra Abdul Aleem and Others Vs. Government of Karnataka and Others*** (W.P.No.40566/2015 and connected matters), where the validity of the Act was under challenge, the State Government placed on record a Government letter dated 30.08.2019 stating that although the Act, 2012 came into force on 03.06.2015 and the Amendment Act, 2017 came into force on 03.06.2017, in view of the conditional interim orders dated 06.10.2015 passed by this Court, the candidates have not undergone the mandatory service. It is further stated that looking into the workability of the Act and the object which it seeks to achieve, the State proposes that even if the Act is made applicable for candidates who had taken their admissions post the

commencement of the Act i.e., 03.06.2015, the object would be achieved. This is because the students who took admission after 03.06.2015 would be passing out in the year 2020-21 and such students who would be freshly emerging from the Colleges could be drawn for compulsory services. The co-ordinate Bench noticed that the concession given by the State Government would not affect the petitioners therein who were admitted to the courses prior to 03.06.2015 and therefore, proceeded to hold that the provisions of the Act and the Rules would not be applicable to candidates who were admitted prior to 24.07.2015, the date on which the Karnataka Act No.26 of 2015 came into force.

15. What is essentially to be noticed is that though W.P.Nos.40566/2015 and connected matters were filed in the year 2015 and interim order was passed on 06.10.2015, staying the operation of the Principal Act along with all further proceedings, orders, actions, notifications including the Rules etc., pursuant to the Act, the Government and the Karnataka Examinations Authority did not endeavour to implement the provisions for the next academic years viz., 2016 onwards. On the contrary, information and instructions of implementation of the Act is provided in the

Information Bulletins starting from the academic years 2018-19 onwards. Accordingly, bonds have been executed by the candidates who sought admission to PG courses from 2018-19 onwards. Therefore, *prima facie*, there is sufficient force in the submission of the learned Counsel for the petitioners that when no such information is given in the Information Bulletin upto 2018-19 and no bonds having been taken at the hands of the candidates, whether the provisions of the Act could be made applicable to the candidates prior to 2018-19, is the question that requires consideration.

16. This contention is sought to be countered at the hands of the Government that it is not mandatory to provide such information in the Information Bulletin. For the sake of arguments, even if this Court were to come to conclusion that it is not mandatory on the part of the Government to provide such information in the Information Bulletin, then the next question that would arise is the requirement of the candidates to execute a bond, undertaking compulsory service. The Information Bulletins issued by the Karnataka Examinations Authority at the instance of the Government contain the information of implementation of the

provisions of Rules, 2006 from the date when the Rules came into force and the provisions of Act, 2012 from the year 2018-19 onwards, as noticed above. The Information Bulletin also contains the prescribed form (Bond) and the candidates are compelled to execute the Bonds. Therefore, in that view of the matter, although it may not be mandatory to provide such information in the Information Bulletin, the Government will not be in a position to compel the candidates into compulsory service, if such Bonds are not taken from the candidates.

17. This issue can also be considered from another angle, as contended by the learned Additional Advocate General, that a provision of law when enacted, comes into operation and becomes applicable, as it has been an established position that it is presumed that the provisions of an enactment is made known to the public on publication of the law in the official Gazette. Therefore, the dictum - ignorance of the provisions of law cannot be an excuse for implementation is pressed into service. The learned AAG has placed reliance on the decisions in ***The Swadeshi Cotton Mills Co. Ltd., Vs. The Government of U.P. and Others (1975)*** 4 SCC 378 and ***State of Bihar and Others Vs. Bihar Distillery***

and Others (1997) 2 SCC 453, in support of his contention.

There can be no doubt about the proposition that ignorance of law is no excuse, but in the present context, students from across the country and in fact from overseas seek admission to Medical courses/PG courses/Super Specialty courses in various Institutions across the country and it is a matter of pride that the Institutions in Bangalore and many other parts of the State have enjoyed the status of premier Medical Institutions and attract students from across the globe. Such students many not have the knowledge of the provisions of a local statute. It is in this context that the Government has felt it necessary to provide the information to candidates regarding the implementation of such statutes and such information is also required to be provided to the candidates to put them on notice and allow them an opportunity to make their choice having regard to the compulsory element in the provisions of the Act. As rightly contended by the learned Counsel for petitioners, students coming from across the country and overseas may not have the knowledge of local laws, which is not so in the case of other provisions of law/regulations like the MCI Regulations, UGC

Regulations etc., which are Central legislations/regulations applicable throughout the country.

18. The publication in the information bulletin also satisfies the dictum, "the aggrieved must be apprised" which is the constitutional creed flowing from the postulates of Article 14 of the Constitution of India. The publication of the information along with the prescribed form is more of a practical requirement than a legal compulsion.

19. Having analyzed the contentions, this Court finds that the students of the academic years 2016-17 and 2017-18 were not made aware of the implementations of the provisions of the instant Act and Rules and no bonds have been executed by the petitioners of the academic years 2016-17 and 2017-18. Therefore, the provisions of the instant Act and Rules shall not be made applicable to the PG students/petitioners who were admitted to the course during the academic years 2016-17 and 2017-18. On the other hand, PG students/petitioners from the academic year 2018-19 onwards have been informed of the implementation of the Act and Rules, following which they have executed bonds undertaking to abide by solemn undertaking. Therefore, the provisions of the

instant Act and Rules shall be made applicable to the PG students/petitioners who were admitted to the course during the academic year 2018-19 and onwards.

Accordingly, the writ petitions stand disposed of.

Pending interlocutory applications, if any, stand disposed of.
