Candidate is instructed to bring “Consent/Choice Form” at the time of offline counseling.
- **The candidate, who will remain absent at the date and time of counseling allotted to them, will have no right for admission.** Authority Letter or Proxy will NOT be allowed for taking admission in offline counseling.
- The candidates will be called as per the merit rank and will be allotted the admission on vacant seats during counseling. If he is not willing to take admission in the offered seat, he can refuse the admission.
- **The candidates, who have taken admission in previous online round of CPS Diploma Courses, have to bring original admission order of ACPGMEC and receipt of paid tuition fees along with Consent/Choice Form for offline round 02 of CPS Diploma courses counselling.**

  8. For SEBC, ST and SC Category: Caste certificate issued by Competent Authorities of Gujarat State only
  9. For SEBC Category: Non-creamy layer certificate (Parishistha '4' in Gujarati/English) issued by Competent Authorities of **Gujarat State only** as per Govt. norms issued after Dt. 01/04/2020.
  10. For EWS (Economically Weaker Sections) Category: EWS certificate issued by Competent Authorities of Gujarat State only issued after Dt. 01/04/2020

- The candidate has to pay tuition fees / difference in tuition fees of one term (six months) by **cash/ Demand Draft** in favor of “ACPUGMEC” payable at Gandhinagar at bank facility provided by Admission Committee, immediately. If candidate has paid tuition fees for admission for previous online round of CPS Diploma Courses, fees will be adjusted according to it. Excess fees will be refunded at the end of whole admission process.
- The candidates are advised to bring specific arrangement of DDs to pay tuition fees at the time of counselling. E.g., The maximum fee is Rs. 9,00,000 (9.00 lakh) (for one term – Six months). So, candidate can bring 3 Demand Drafts of Rs. 3,00,000 each based on your choice of college to secure admission in Merit Quota / Institutional Quota seats.
