• ACPPGMEC is going to organize Offline Round 03 for Spot Admission in CPS Diploma Courses in Vacant seats for academic year (2022-23) at below mentioned Medical College.

- All the candidates are instructed to see the vacancy status available for CPS Counselling on website of admission committee. The admission committee shall allot the seats as on available vacancy.
- It is mandatory for all the candidates, who want to participate in the Offline Round 03 for Spot Admission in CPS Diploma Courses, have to remain present at above mentioned place along with all necessary original documents and required tuition fees.
- The candidate, who will remain absent at the date and time of counseling allotted to them, will have
 no right for admission. Authority Letter or Proxy will NOT be allowed for taking admission in offline
 counseling.
- The candidates will be called as per the merit rank and will be allotted the admission on vacant seats during counseling. If he is not willing to take admission in the offered seat, he can refuse the admission.
- The candidate, are required to bring following original documents at the time of counseling.
 - 1. All year MBBS attempt-wise Marksheets
 - 2. 12 months internship completion certificate
 - 3. Provisional Registration of State Medical Council OR Medical Council of India OR Permanent Registration of State Medical Council OR Medical Council of India
 - 4. Copy of NEET-PG-2022 Marksheet
 - 5. Document showing place of birth & Date of Birth & Indian Citizenship: School leaving Certificate/ Transfer Certificate/ Passport/ Birth Certificate
 - 6. Domicile Certificate (with signature and stamp of Authority) issued by Competent Authorities (Mamlatdar / Executive Magistrate / Commissioner of Police) of Gujarat State only (in case of candidate born outside of Gujarat)
 - 7. For SEBC, ST and SC Category: Caste certificate issued by Competent Authorities of Gujarat State only
 - 8. For SEBC Category: Non-creamy layer certificate (Parishistha '4' in Gujarati/English) issued by Competent Authorities of Gujarat State only as per Govt. norms issued after Dt. 01/04/2020.
 - 9. For EWS (Economically Weaker Sections) Category: EWS certificate issued by Competent Authorities of Gujarat State only issued after Dt. 01/04/2020
 - 10. 12th Marksheet
 - 11. Domicile certificate of Gujarat state: For candidates who have done MBBS/BDS outside Gujarat & only if birth place is outside Gujarat)
 - 12. Photocopy of Disability certificate issued by competent authority (if applicable)
 - 13. NBE Screening Test result in case of Foreign Medical Graduate students
- The candidate, without original documents and prescribed fees, will not be granted admission under any circumstances.
