**NEET-PG-CPS-2021**

**Extended Personal Counselling Round for admissions to Medical Postgraduate CPS Fellowship/ CPS Diploma Courses at Maharashtra State Government/Corporation Medical College/Hospital and Unaided Private Institutes/ Hospital for Academic Year 2021-22 through NEET PG 2021 Merit on vacant seats**

**Ref - Government of Maharashtra Letter No. MED-1022/CR 320/22/Edu-2, Dated 02.11.2022.**

As per the aforesaid reference letter from Medical Education and Drugs Department, Govt. of Maharashtra has permitted to conduct process of allotment for filling remaining vacant seats of CPS courses for the academic year 2021-22.

As per this notice these remaining seats are going to be filled by way of extended personal counselling round. During this process admission for the following type courses will be conducted-

1. CPS courses recognised by National Medical Commission.
2. CPS courses not-recognised by National Medical Commission, but approved by the Maharashtra Medical Council.

The CPS courses recognised by National Medical Commission will be allotted from eligible candidates as per lowered cut-off-percentile as mentioned below -

Maharashtra Medical Council approved vacant CPS courses will be allotted to NEET-PG-2021 appeared candidates as per their merit.

The desirous NEET-PG-2021 eligible as well as appeared candidates should submit registration/information online on website i.e. www.med-edu.in. This information submitted will be used for preparation of provisional merit list for extended Personnal Counselling Round of NEET-PG-CPS

2021 process for Maharashtra State. Those candidates who are previously registered and Not Allotted a seat alongwith newly registered candidates will be eligible for this extended Personal Counselling Round. Candidates of previously conducted/completed admission process of NEET-PG-CPS-2021 and having "Admitted" status during CAP 1<sup>st</sup> round / 2<sup>nd</sup> round / Mop up round and Personal Counselling Round in Govt. / Corporation / Govt. aided / Private unaided / Minority Medical Institutes are "NOT ELIGIBLE" for this online registration process. The said process will be carried out as per following schedule.

#### **Procedure of Personal Counselling Round for NEET-PG-CPS 2021**

1. All the desirous candidates who are eligible as per the rules should attend the personal Counselling round **IN PERSON (PROXY WILL NOT BE PERMITTED)** according to the above schedule. The candidates are instructed to report to the Counselling centre half an hour before the above mentioned schedule. If any candidate reaches late to the Counselling centre, he will be considered eligible for the remaining seats available at that time only.
2. As per rule no 8.2 of NEET-PG-CPS 2021 Information Brochure, the candidates should bring all the original documents and one set of self-attested photocopies of the same for verification at the Personal Counselling Centre.
3. The provisional State Merit List for the extended Personal Counselling round will be published on the website on 10.11.2022.
4. The extended personal Counselling will be held strictly in order of merit i.e. CPS SML number. Each candidate will be offered all seats those are vacant and are available for allotment at the time of his/her turn of Counselling.
5. In this round, allotment shall be made on the basis of choice made on the spot by the candidate at the time of personal Counselling appearance.
6. Allotment of seat once made in this extended personal Counselling round, shall not be changed and / or cancelled at any count whatsoever. Therefore, while giving the choice on spot at the time

of this personal Counselling round, the candidates must consider the available seats thoroughly and opt for a seat which they must join once allotted.

7. The rule of inter-se will be strictly followed if any reserve category seat remains unfilled. Please refer Annexure "D" Page No. 31 to 33 of NEET-PG-CPS 2021 Information brochure.
8. If a candidate is allotted any seat in extended personal Counselling round, he/she will not be considered for Inter-se round if any.
9. Once a seat is allotted during extended Personal Counselling round, the candidate should report to the allotted institute to join and complete all the necessary formalities by submitting all his/her original documents along with payment of requisite fees in the form of Demand Draft before 17.11.2022, 5.00 pm.
10. It is the sole responsibility of the candidate to submit all his original documents and requisite fees to the allotted institute within the prescribed time limit.
11. If any candidate resigns the course from the seat allotted through Extended Personal Counselling Round of NEET-PG-CPS 2021 admission process after the cut-off date, there will be no refund of fees and such candidates will have to pay entire course fee as penalty.
