Sub: Revision of NEET-MDS 2021 results.


Sir,

I am directed to say that this Ministry has decided to lower the qualifying cut-off percentile for NEET-MDS, 2021 by **23.029** percentile for each category (General, SC/ST/OBC and UR-PWD) in pursuance of the 2<sup>nd</sup> proviso in clause 7(1) of DCI's Master of Dental Surgery Course (1<sup>st</sup> Amendment) Regulations, 2018. The qualifying percentiles for NEET-MDS, 2021 for the academic session 2021-22 now stand lowered as under:

1. The result of NEET-MDS 2021 was declared on 31<sup>st</sup> December 2020. In accordance with the Ministry of Health & Family Welfare, Govt. of India letter F.No. V.12025/154/2021-DE dated 10<sup>th</sup> November 2021, the minimum qualifying percentiles have been lowered [in pursuance of the 2<sup>nd</sup> Proviso in clause 7(1) of DCI's Master of Dental Surgery Course (1<sup>st</sup> Amendment) Regulations, 2018] as follows:
