> Sub.: To finalise Seat Matrix Chart Subject-wise for admitting students in Academic Year 2023-24

Sir/Madam.

With reference to above, I am to state that the admission process of Postgraduate MDS courses will commence soon by the Admission Regulatory Authority (ARA) for Academic Year 2023-24 & thereby University needs to submit Seat Matrix of all Colleges by 25th March 2023 to their office.

Please find attached herewith a copy of sample Seat Matrix Chart with request to kindly verify "Intake Capacity as sanctioned by the Dental Council of India" as well as fill-up information under "Status of Council (Recognised / Permitted Seats)" & "Max Seats Permitted as per Teacher: Student Ratio" in view of following guidelines:

- 1. "Teacher: Student Ratio" shall be calculated by the College in view of guidelines prescribed by DCI in view of Unit composition with Bed Strength.
- 2. In case PG Seats are decreased due to Non-availability of PG Recognised Teacher, it shall be marked as "@" & Non-fullfillment of Unit Criteria shall be marked as "#" under "Max Seats Permitted" column. In case if any teacher is going to superannuate, then the College shall ensure that the Guide will be made available to the admitted students.
- 3. In case if PG Seats of any Subject(s) is/are decreased or stopped by the DCI, it shall be marked as "\$" "Max Seats Permitted" column & shall be submitted alongwith supporting document/(s) of the DCI.
- 4. In case if PG seats of any subject(s) is restored by the DCI, it shall be marked as "&" "Max Seats Permitted" column & shall be submitted alongwith supporting document/(s) of the DCI.
- 5. Information of "Recognised" & "Permitted" Seats shall be filled-in as per factual status granted by the GOI / DCI.
