C.G. State Foreign Medical Graduates (FMGs) – Internship Counselling 2025

Important Instructions :

- 1. The Foreign Medical Graduates who are willing to start the Internship in Chhattisgarh, are required to fill online form of FMG Internship through available link on Chhattisgarh Medical Education official website (www.cgdme.in) to be considered for Internship Training and the application are accepted only on pro rata basis, based on no. of FMG Seats available in the Medical Colleges of Chhattisgarh.
- 2. Every candidate has to select all colleges/institutes according to their choice in the choice-filling section. If Any candidate has selected a few or limited colleges/institutes and does not get seat allotment in those colleges/institute in accordance with his/her merit, then in any circumstances he/she will not be allotted an internship in this session. Therefore, every candidate is hereby specially informed to select all institutes according to his/her choice.
- 3. Candidates enrolled should ensure that information entered during the online submission of application form is correct and factual.
- 4. Application of candidates producing false or fabricated records will not be considered & appropriate action will be taken if false or fabricated records/ information is submitted.
- 5. Application form once submitted cannot be withdrawn. Chhattisgarh Provisional Registration Fee shall not be refunded/ adjusted under any circumstances. Chhattisgarh Provisional registration certificate

will be issued to only those candidates who have joined internship from the Chhattisgarh Medical Colleges allotted through counselling.

- 6. Chhattisgarh Medical Counselling Committee has the right to reject any application in case it doesn't fulfil the criteria/time-schedule or the applications received are more than the seats available in Medical Colleges in Chhattisgarh.
- 7. The allotment will be made only in the participating Medical Colleges in Chhattisgarh.
- 8. In case of any dispute, the decision of the FMG Counselling State Counselling Committee shall be final and binding.
- 9. The Counselling of internship seat allotment will be conducted only in a single round.

Eligibility:

Candidates who have qualified the NBE/FMGE (Screening Test) are eligible to participate in the e-counselling process for the FMG Internship Program in Chhattisgarh State.

Merit List Preparation :

After the online application process, the merit list of registered candidates will be prepared as follows:

Merit List 1: Candidates who are residents of Chhattisgarh (based on domicile certificate)

Merit List 2: Candidates from other states

In case of a tie in marks:

- Preference will be given to the older candidate (based on date of birth).
- If the date of birth is also the same, preference will be based on the first letter of the candidate's name in alphabetical order.

Allotment

Allotment will first be given to candidates with Chhattisgarh domicile, and then to candidates from other states.

Downloading the Internship Seat Allotment Letter

Selected candidates must download their Internship Seat Allotment Letter through their portal login.

Reporting to the Allotted College

It is mandatory for every selected candidate to report to the allotted college/institute within the prescribed time. Candidates must immediately join the internship program, failing which their seat will be considered vacant.

Required Documents

- Candidates must submit all self-attested documents along with the provisional registration receipt at the allotted college/institute for verification.
- If the provisional registration receipt is not available at the time of reporting, candidates may submit an affidavit and must provide the receipt within 15 days.
- An affidavit on a Rs. 50/- stamp paper, duly notarized, must be uploaded and its original copy submitted to the allotted college/institute (as per prescribed format).

Duration of Internship

As per NMC guidelines, candidates who have completed their studies through online mode must undergo internship as per the applicable norms.

Provisional Registration

Candidates included in the merit list and who have joined the internship must apply for provisional registration with the Chhattisgarh Medical Council within 15 days.

Internship Stipend and Other Conditions

The internship stipend will be determined as per government orders and will be paid by the concerned college/institute.

The Directorate of Medical Education, Chhattisgarh will not be responsible for determining or disbursing the stipend.

Instructions for Allotted Medical Colleges/Institutes:

1. Verification of Original Documents

- All allotted colleges/institutes must verify the original documents of the candidates.
- Verification of the provisional registration receipt must be completed within 15 days.
- If any discrepancy is found, the college/institute has the right to deny internship participation to the candidate.

List of Documents Required for FMG Verification:

- I. Class 10th Marksheet
- II. Class 12th Marksheet
- III. Eligibility Certificate issued by NMC
- IV. MBBS Degree or Equivalent Certificate
- V. FMGE Pass Certificate/Screening Test Certificate
- VI. Chhattisgarh Domicile Certificate (if applicable)
- VII. Original Affidavit (as per prescribed format)

2. Issuance of Internship Certificate

After successful completion of the internship, the college/institute must provide the candidate with an Internship Continuation and Completion Certificate.
