Notification regarding application to participate in Centralized merit based online counseling for admission to Sponsored DNB seats (Post MBBS and Post Diploma) 2022

In view of the NBEMS notification dated **05.08.2022** in website www.natboard.edu.in, the application for participation in **Centralized merit based online counseling for admission to Sponsored DNB seats (Post MBBS and Post Diploma) 2022** is sought from the eligible candidates.

1. Eligibility Criteria for Sponsored DNB (Post MBBS) seats:

- I. Candidates who are working in a Government (State/Central/Autonomous/PSUs, etc.) organization on a regular basis are eligible for Sponsored DNB (Post MBBS) seats.

AND

- II. Candidates must be in possession of MBBS degree/Provisional Pass as per the provisions Certificate recognized of the Indian Medical Council Act 1956 and possess permanent / provisional registration certificate of MBBS qualification issued by the Medical Council of India/ State Medical Council.

AND

- III. Must have "**Qualified**" NEET PG 2022.

2. Eligibility Criteria for Sponsored DNB (Post Diploma) Seats:

- I. Candidates who are working in a Government (State/Central/Autonomous/PSUs, etc.) organization on a regular basis are eligible for Sponsored DNB (Post Diploma) seats.

AND

- II. Candidates who have passed the final examination leading to the award of PostGraduate Diploma from Indian Universities which are duly recognized as per provisions of Indian Medical Council Act 1956, Govt. of India i.e. have passed final examinations for Post graduate diploma on or before **31st July 2022**.

AND

- III. Candidate must have "**Appeared**" in DNB-PDCET 2022.

3. All such candidates who fulfill the aforesaid eligibility criteria and are desirous for opting the sponsored DNB (Post MBBS and Post Diploma) seats 2022 are required to submit his/her application to the **Director of Medical Education, Dept of Health and Family Welfare, Swasthya Bhawan, GN-29 , Sector –V, Kolkata -700091**. (If they belong to WBMS cadre) or **Director of Health Services, Dept of Health and Family Welfare, Swasthya Bhawan, GN-29, Sector –V, Kolkata -700091**(If they belong to WBHS or WBPB and AS cadre).

"Such application shall also accompany the following documents (one set of self attested photocopies) to be submitted for verification before **Assistant Director of Medical Education** at the **Counseling Cell in the ground floor of Swasthya Sathi Building** within premises of **Swasthya Bhawan** (for WBMES cadre) or **Assistant Director of Health Services, MERT, Swasthya Bhawan** (if they belong to WBHS/WBPH and AS cadre).

The candidate shall himself/herself attend such verification along with original documents.

The format for application dated **20.07.2022** is already uploaded in websites www.wbhealth.gov.in and www.wbmcc.nic.in.

The following documents are required to be placed for verification (original and one set self attested photocopy):-

1. NEET PG 2022/DNB PDCET 2022 ----rank card and admit card
2. Any two of following valid photo ID (Aadhar card/Voter card/Passport)
3. Age proof (birth certificate/class X admit card/class X certificate)
4. MBBS certificate and final MBBS mark sheet
5. Permanent Registration certificate issued by MCI/NMC/WBMC
6. Caste certificate (as applicable and issued by appropriate authority in West Bengal)
7. Non creamy layer certificate for OBC candidates issued on or after 01.04.2021
8. PwD certificate (as applicable and issued by Medical Board of IPGIMER Kolkata)
9. Internship completion certificate
10. Proof of previous Diploma if acquired (on or before 31.07.2022)
11. Proof of any bond formalities (if applicable to be completed on or before 31.07.2022)
12. ID card of present employment and No Objection Certificate from present employer and Certificate from present employer stating 3 yrs. of regular service in the State of West Bengal along with mention of present place of posting. Such letter must also clearly indicate that the candidate would avail salary from his/her present employer during the PG training period.
13. Posting order and joining report as a proof of regular service.

The last date for submission of application is by **4 pm of 23.08.2022**. The verification shall be conducted from **12 noon till 4 pm on 24.08.2022, 25.08.2022, 26.08.2022** at the stated venue. The candidates who have submitted their applications within **18.08.2022** are schedule to attend for verification along with original documents **on 24.08.2022**. The candidates who submit their documents on **22.08.2022** are allowed to attend for verification along with original documents **on 25.08.2022**. The candidates who submit their documents on **23.08.2022** are allowed to attend for verification along with original documents **on 26.08.2022**.

The candidates who are fail in verification or does not attend with required documents within schedule time, shall not be included in the list for provisional NOC (No Objection Certificate) for Centralized merit based online counseling for admission to Sponsored DNB seats (Post MBBS and Post Diploma) 2022.

The provisionally eligible candidates shall be handed Provisional NOC in authenticated letter head and the scanned copy shall be uploaded in the websites www.wbhealth.gov.in and www.wbmcc.nic.in for public viewing on or after **29.08.2022** and shall also be communicated to NBEMS as per their instructions via email counseling.cc@natboard.edu.in latest by **31.08.2022**. The format of NOC shall be as per provided by NBEMS in their notice **05.08.2022** in the website www.natboard.edu.in.

The candidates shall bear in mind that this NOC is purely provisional and in no way ensures a seat for a particular candidate. The in-service candidates of Dept. of Health and Family Welfare, Govt. of West Bengal must contact respective branch officials to find out whether they are eligible for trainee reserve as per extant rules so that seats are not wasted after allotment if any.
