Notice, Counseling process, Schedule and Seat Matrix for State Quota Post
Diploma Two Years DNB Degree Sponsored Seat Counseling 2022
In Govt Hospitals of West Bengal

#### → General information:-

Admission to the State Quota Post Diploma 2 years Sponsored Degree seats in DNB Courses in West Bengal is going to commence for Govt. Hospitals in The State West Bengal affiliated under NBEMS.

A. The eligibility for Post Diploma 2 years Sponsored Degree seats are:

- 1. Such broad specialty seats shall be only for in-service candidates doing regular service in the Department of Health and Family Welfare; Govt. of West Bengal.
- Such in service candidates should have appeared in DNB PD CET 2022 examination.
- 3. Candidates who have passed the final examination leading to the award of Post Graduate Diploma from Indian Universities which are duly recognized as per provision of the Indian Medical Council Act, 1956, Govt. of India that is they have passed final examinations for Post Graduate Diploma on or before 31<sup>st</sup> July 2022. This is as per handbook for Post Diploma seats published by NBE in the website www.counseling.nbe.edu.in
- 4. The allotment for such seats in the DNB affiliated Govt hospitals in West Bengal approved and accredited by NBEMS and seat sharing accepted by NBEMS for 2022, shall be made on the basis of the subject wise inter se merit of Status, (Unreserved, Scheduled Caste, Scheduled Tribe, Other Backward Class A, Other Backward Class B and Person with Disability) of such in service candidates.

In reservation of seats for SC, ST, OBC A, OBC B candidates, policy expressed in West Bengal State Higher Education Institutions (Reservation in Admission) Act 2013 shall be followed. For Post Diploma 2 years Degree seats, separately the 100

point roster of Backward Class Welfare Department, Govt. of West Bengal shall be applied for reservation of seats.

OBC category candidates have to submit non creamy layer income certificate issued on or **after 01.04.2021** by the caste certificate issuing authority. If they fail to provide such certificate, they shall be considered as Unreserved candidate for the counseling process provided they have obtained the eligibility marks of Unreserved candidates.

The caste certificate issued by the appropriate authority in the State of West Bengal shall only be valid for allotment to the reserved category seats of such counseling. If such certificate could not be provided by the candidate during counseling verification process, the candidate shall be considered as Unreserved for the counseling process provided they have obtained the eligibility marks of unreserved candidates.

Five percent seats of the sanctioned capacity shall be filled up by the Persons with Disabilities candidates under each caste category. If no such eligible candidate is available in the counseling then the seat shall be reverted for respective caste category.

The benchmark PwD (Person with Disability) certificate must be issued from Medical board of IPGMER Kolkata which is in accordance with the provisions of the Rights of Persons with Disability Act 2016.

There is no scope for correction or modification of caste or PwD status by the candidate after commencement of the counseling process.

- **B.** Tenure of training period is two completed years for Post Diploma broad specialty DNB course. Date of start of training period shall be the date of actual placement on trainee reserve for in service candidates (that is the date of drawl of salary as trainee reserve) by the admitting Govt Hospitals with accredited DNB course in West Bengal.
- C. Admission to such course shall not be allowed unless the candidate has got himself/herself registered with the West Bengal Medical Council. Candidates registered with other State Medical Council shall have to be registered with West Bengal Medical Council before admission.



D. Placement on trainee reserve is strictly based on extent T.R rules issued by Health and Family Welfare Department, Government of West Bengal. The total number of allotment in Trainee Reserve (WBHS/ WBMES/WBPHAS) will be as per available TR posts for 2022 based on caste and inter se merit of in service candidates as per direction of Health and Family Welfare Department, Government of West Bengal. If there is a tie with TR post being less than the eligible candidates, higher the duration of regular service would be considered earlier for TR post. If still tied, then higher the chronological age of the candidate would be considered earlier for TR post. Mere enrolment for participation in Counseling does not confirm placement in training reserve, which is at the discretion of the Dept of Health and Family Welfare, Govt. of West Bengal.

Eligibility of in service candidate pursuing or in possession of Post MBBS PG Diploma in any discipline and placed on Trainee Reserve at any time during the service career is also subject to the prevalent rules and orders in place of the Department of Health and family Welfare, Govt. of West Bengal. **PG Degree holder shall not be eligible for further PG course in DNB** (even if such degree was acquired before joining service) but only PG Diploma holder may opt for DNB Post Diploma 2 years Degree course if the required period of service is rendered in consonance with the TR Rules of 2015 with its latest amendment.

**E.** Candidates already pursuing a DNB course or any other Post Graduate Medical course are not eligible for admission in such 2 years Post Diploma Degree seats 2022, till they complete the entire duration prescribed in the said course. Resignation or discontinuation from the said course due to any reason shall not make the candidate eligible for admission for such seats.

F. The candidates who have already admitted in PG Medical AIQ Round 2 in 2022 counseling or WB SQ PG Medical Round 2 in 2022 counseling, are out of this 2022 State Quota PDCET counseling process.

The candidates, who are allotted in AIQ PG medical Mop up counseling 2022, are also not allowed to participate in this counseling process.

G. In service candidate who did his/her Diploma through placement on Trainee Reserve are allowed to apply provided the TR period for pursuing such Diploma/fellowship course was completed on or before 30.04.2020.




H. It is reiterated that candidate is not eligible if he/she is more than 50 years of age on 31.03.2022 as per provision of the Rule 3 sub rule IV of the TR Rules 2015 with latest amendment.

If at any stage of counseling or admission or thereafter, the candidate is found to be unfit for availing TR as per the latest TR rules and amendments and/or found to have furnished incomplete/false/fabricated information, his/her candidature shall be summarily rejected.

The original documents (as applicable) and one photo copy self attested per all such original document has to be submitted by the candidate during verification process of the counseling and if found to be appropriate then the counseling slip shall be handed over to such candidate for appearing in the manual counseling for seat allotment on the same day.

### → List of such documents are as follows:-

- 1. DNB PD CET 2022 Admit card
- 2. DNB PD CET 2022 Rank card
- 3. Valid photo ID card of the candidate (EPIC/AADHAR/PASSPORT/PAN/Driving License....any one)
- 4. Age Proof (Birth Certificate/Class X admit card/Class X certificate)
- 5. MBBS Certiifcate
- 6. 3<sup>rd</sup> Professional Part II examination Mark sheet
- 7. Internship Completion Certificate
- 8. Caste certificate (as applicable)
- 9. Non Creamy layer certificate issued on or after 01.04.2022 for OBC A or OBC B candidates
- 10. Permanent Registration Certificate issued by WBMC (West Bengal Medical Council)
- 11. PwD certificate issued by the Medical Board of IPGMER Kolkata (as applicable)
- 12. Proof of Previous Diploma (as applicable) Certificate along with proof that such candidate passed such Diploma final examination on or before 31<sup>st</sup> July 2022 (as applicable).
- 13. Proof of previous TR (Trainee Reserve) related formalities completed by 30.04.2020 (as applicable)
- 14. Posting order/s and joining report/s for claiming in service category seats



Needless to mention that the candidate without original documents shall not be verified and shall not be allowed to participate in the manual counseling for allotment of State Quota DNB PDCET Sponsored seats in West Bengal 2022.

## → Counseling process:-


The State Quota DNB PDCET sponsored seats shall be allotted through manual counseling and the candidate has to be manually present for such counseling offline at Swasthya Bhavan, GN-29, Salt Lake Kolkata 700091.

Step 1 verification and counseling slip generation: At first the candidate has to verify the original documents at the verification desk. They have to deposit the non refundable counseling fee in the form of a Demand Draft payable at Kolkata in favour of the Medical Education Fund of DME kept under West Bengal State Health and Family Welfare Samiti Swasthya Bhavan of the amount of Rs 3000/- (Rupees Three Thousand only). For preparation DD one may use the short form: Medical Education Fund of DME, WBSH&FW Samiti.

After verification and handing over of the one set photocopy of self attested documents (to be brought in a folder by the candidate with identification pasted over it) the verified candidate shall be offered the **counseling slip**. The candidate now can wait with such slip in the counseling venue. This process is time bound and once the schedule time is over, no candidate shall be allowed to enter the hall for verification and such candidate cannot participate in the counseling process.

If the candidate fails in the verification process then he/she cannot participate in the counseling process and have to leave the counseling hall at once. Parent/guardian is not allowed inside the hall however candidate can consult with them via self mobile phone.

Step 2 the counseling proper and seat allotment and generation of allotment letter: The candidates shall be called in order of combined merit rank (subject wise) and the category candidates can place choice for their respective category seats or Unreserved seats (provided they have attained the Unreserved qualifying cut off marks in the qualifying examination as applicable). An Unreserved candidate can apply only for unreserved seats as per combined merit rank.



If a candidate gets allotment then counseling for him/her shall end. If the candidate declines seat at this stage then can again be called after seat conversion process.

The seat conversion rule (if no eligible applicant candidate is available for such seat) as below:-

SCPWD $\rightarrow$ SC, STPWD $\rightarrow$ ST, OBC A PWD $\rightarrow$ OBC A, OBC B PWD $\rightarrow$ OBC B, URPWD $\rightarrow$ UR, SC $\leftarrow$  $\rightarrow$ ST and vice versa, OBC A $\leftarrow$  $\rightarrow$ OBC B and vice versa. (Only one rotation of seat conversion shall take place).

Once the candidate confirms the seat then the allotment letter shall be generated and 2 copy shall be printed where in both the copies the candidate and the authorized signatory of the Dept of Health and Family Welfare, Govt. of West Bengal shall have to put signature and one such copy shall be retained by the counseling authority and the other such copy shall be handed over to the candidate.

Once the candidate thoroughly checks the allotment letter and is satisfied with such letter, he/she shall leave the auditorium at once in order to avoid the overcrowding. No request for change of seat shall be entertained. The counseling in both case ends once the seats are exhausted or the eligible candidates are exhausted whichever is earlier.

The candidates are advised to report on time for verification and seat allotment. After the schedule time is over no request for verification or seat allotment can be considered.

The allotted candidate has to report to the concerned Govt Hospital Superintendent with the said allotment letter and the Hospital DNB Co-ordinator along with all such original documents as stated earlier and have to pay the requisite fee for admission as stipulated by National Board of Examinations in Medical Science (NBEMS) in their Information Bulletin 2022. The candidate also have to provide such Govt Hospital with the one photo copy self attested document for each of such credentials along with 4 copy passport size recent photographs.



Needless to mention that if the candidate fails to report to the allotted Govt Hospital with all required credentials and fee within due time and fail to complete all the admission related formalities within due time frame, then the candidate cannot claim for such seat at a later date.

On reporting for admission, the candidate has to deposit the original credentials to the Govt Hospital authority where the authority shall provide them with the receipt of such documents. Such receipt has to be carefully preserved by the candidate till the completion of the course tenure. After completion of the course tenure the candidate can take back such original credentials by depositing such receipt to the authority.

The allotted candidate has to pay Rs 1, 25, 000/- (Rupees One lakh and Twenty Five Thousand only) in Cash/Draft/Online payment to the concerned hospital (after discussing the payment mode with the allotted hospital authority) as one year course fee as prescribed by the NBEMS. The fee once paid after admission in the allotted seat shall be non refundable.

The joining in the course shall be after issuance of TR by the Department of Health and Family Welfare, Govt of WB. They shall be receiving the due salary as per extant rule. They are not eligible for any other stipend. The **joining report** and **in-service bond affidavit** (The service bond is as per the State policy of TR rules 2015 and related amendments from time to time) has to be provided by the candidate to the respective Govt Hospital and the Hospital has to provide the same proof to NBEMS for registration of the said in-service candidate for the said course.
