PG (MEDICAL) STRAY VACANCY ROUND UNDER MANAGEMENT QUOTA SEATS 2024-25

Admissions into Post Graduate Medical Degree/Diploma Courses against Stray Vacancy Round conducted by Dr. NTR UHS for the academic year 2024-25 in the State of Andhra Pradesh under Management Quota Post Graduate Medical Degree / Diploma courses i.e., S1/S2/S3 in Private Un-aided Non-minority and Minority Medical Colleges affiliated to Dr. NTR UHS.

Dr. NTR UHS invites Online applications for the vacant seats after the MQ Phase-III (Mop Up) round from the eligible candidates for admission into **Stray Vacancy** seats of Post Graduate Medical Degree / Diploma Courses under Management Quota seats i.e., S1/S2/S3 in PG (Medical) Courses in Private unaided Non-Minority and Minority Medical Colleges in the State of Andhra Pradesh for the academic year 2024-25. For complete details refer Prospectus placed in the website on 27-09-2024.

Security Deposit Amount:

- a) Many candidates who were allotted seats under Management Quota, 2024-25 during Phase-III (Mop Up) Round of Counselling did not report in the allotted colleges which leads to blocking of seats.
- b) To avoid such blocking of seats, the Competent Authority has decided to collect a Refundable Security Deposit Amount of ₹.3,00,000/- (Rupees three lakhs only) through online mode from the candidates who are found in the Stray Vacancy Round Consolidated Merit List of Management Quota and who wishes to participate in the ensuing **Stray Vacancy Round of Counselling** subject to the conditions that:
 - i. Security Deposit of candidates who do not join the seats allotted to them in Stray Vacancy Round or subsequent rounds, if any, will be forfeited and such candidates will be debarred from participating A.P. State Counselling for admission to PG (Medical) Courses under both Competent Authority Quota seats & Management Quota seats for the next academic year.
 - ii. If the candidate joins the allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.
 - iii. If the candidate is not allotted seat, the Security Deposit amount will be refunded to the candidate after closure of admissions.
 - iv. Also, the Security Deposit will be forfeited if the admission gets cancelled due to any reason. e.g. in case the candidate provides wrong information at the time of registration on the basis of which a seat is allotted and later cancelled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of admission (within stipulated time)

Web Options:

- a) Eligible candidates will have to exercise fresh web options for Stray Vacancy Round.
- b) Candidates participating in Special Stray Vacancy Round will have to remit an amount of ₹.3,00,000/- (Rupees three lakhs only) and also have to furnish an undertaking with respect to allotment of seats at the time of exercising web options as under:

“I agree to participate in the Special Stray Vacancy Round of Dr. NTRUHS. I affirm that, I am not holding any seat in the previous rounds of NEETUG Counselling, 2024 of All India Quota/State Quota.

I understand that these seats are precious in nature. Hence, if I am allotted a seat during the Special Stray Vacancy Round, I will join the allotted seat. If, due to any reason I do not join the allotted seat my security deposit will be forfeited and, I will be debarred from participating A.P. State Counselling for admission to PG (Medical) Courses under both Competent Authority Quota seats & Management Quota seats for the next academic year. The Competent Authority can take any action including legal/criminal against me in the event that the details furnished by me found to be false.”

INSTRUCTIONS

1. Fresh registrations and fresh choice filling will be obtained for Stray Vacancy Round. Candidate whose names already present in the Consolidated MQ Merit list and not holding any seat are also eligible for Stray vacancy **provided they satisfy the eligibility conditions of Stray vacancy round** and hence they need not apply again for Stray vacancy notification.
2. All unfilled S1B seats are converted as “S1A seats”.
3. Candidates registered and present in the Consolidated Final Merit list but not holding a seat or got no seat in Phase-I, Phase-II & Phase-III(Mop Up) {AIQ/Deemed/State} and willing to participate in the Stray vacancy round can opt to upload relevant documents for S2 (NRI) and S3 (Institutional Quota) without fresh registration.
4. **Eligible candidates:**
 - a) Eligible candidates who are not holding a seat or got no seats in Phase/Round-I, II&III (AIQ, State, Deemed) can participate in Stray Vacancy Round.
 - b) The candidates who have been allotted, but not joined in Phase/Round I, Phase/Round II of State Quota and All India Quota are eligible to participate in Stray counselling.
5. **Not Eligible Candidates:**
 - a) The candidates who are holding PG (Medical) seat in Phase-I & II of State Counselling are not eligible to participate in Stray round of counselling.
 - b) A candidate allotted a seat in Phase III (Mop up) of State counselling cannot participate in further rounds of State Counselling.
 - c) The candidate who is holding a seat allotted in Round 1, Round 2 and Round 3 of All India Quota/Deemed universities (conducted by MCC/DGHS).
 - d) The candidates who have been allotted in stray round of All India Quota/Deemed universities (conducted by MCC/DGHS) are not eligible to participate in State Stray Round of counselling.

- e) The Candidates who have been allotted seats in the CQ Stray Round will not be eligible for the MQ Stray Round, regardless of whether they applied or chose options in that round.
6. If a candidate is allotted a seat in Stray round, he/she has to **compulsorily** report & join the allotted seat/college else the Security deposit amount will be forfeited and he/she **shall be debarred** from participating A.P. State Counselling for admission to PG Medical Courses under both Competent Authority Quota seats & Management Quota seats for subsequent 1 (one) academic year. For complete details refer Prospectus placed in the website on 27-09-2024.
7. The candidates should secure the following revised cutoff Percentile and above in NEET PG –2024 for Post Graduate Medical Degree/Diploma courses:

General/EWS	15 th percentile and above
UR-PwBD	10 th percentile and above
SC/ST/OBC (Including PwBD of SC/ST/OBC)	10 th percentile and above

11. **Mere applying under this notification does not confer any right to claim seat and the candidature is subject to availability of seats. Hence, the candidates are advised to take calculated decision before applying under this notification. Fee once paid shall not be refunded under any circumstances.**
12. The online application can be filled through any **desktop or laptop** only.
13. Online application form without uploading mandatory Certificates, Passport size photo, signature, incomplete information will be automatically rejected and will not be considered for determining the Merit position in respective categories using NEET PG-2024 Rank.
14. **Registration along with uploading of Scanned Original certificates and exercising of web options will be permitted only once irrespective of the Number of counselling.** No separate notification will be given for verification of original certificates. Therefore, the candidates should register and upload all the mandatory Certificates without fail.
15. **The Candidates are hereby informed that if they have secured admission in Medical colleges of other States, joined the course and if they are involved in blocking of the seats the University will initiate legal/criminal action and same will be informed to the NMC/MCC, New Delhi.**
16. If the information furnished by the candidate in the application is incorrect or false or found fake and enclosed forged certificates / documents, during the admission process or later, then the University will take action that deems fit as per rules against the candidate including cancellation of seat, in case already admitted, without any notice. Further action against such candidate will be taken by the University.
